The McKinney Downtown Business Re-Development Board of the City of McKinney, Texas met in regular session at the McKinney Performing Arts Center, Ruschhaupt Hall, 111 N. Tennessee Street, McKinney, Texas on May 14, 2020 at 8:30 a.m.

McKinney Main Street Chairman Robert Hamilton called to order the meeting of the McKinney Downtown Business Re-Development Board at 8:34 a.m. after determining a quorum present. 20-0371 City Liaison Report

Chairman Hamilton called for the City Liaison Report. Ms. Flom updated the Board on the City of McKinney Covid-19 response efforts. The city maintains a hotline for residents that can provide resources and information, and the city staff was able to contact over 7000 seniors to check in and offer assistance. The Covid 19 small business grant is open and there are 271 applicants so far, the city will start funding these grants as soon as possible. Collin County is receiving funds via the Cares Act and this additional money can be used for grants to aid residents with rent, utilities, food etc., and this grant process will be up and running soon.

20-0372 Director's Report

Chairman Hamilton called for the Director's report. Ms. Rosenthal updated the Board on the Louisiana street construction, this project if moving forward, starting soon and Main Street will focus on helping business through this process. Main Street continues to support Downtown by mailing out 5000 postcards promoting local restaurants and delivery services. The McKinney Strong t-shirt campaign has raised over \$24,000, these funds will be distributed to non-profits and businesses.

Chairman Hamilton called for review and action on the Minutes of the last Board meeting. Board members unanimously approved the motion by Board member Julie Williams, seconded by Board member Taylor Phelan, to Approve and Refer the Minutes of the Main Street Board Meeting of March 12, 2020.

Chairman Hamilton called for review and action on the financial reports. Board members unanimously approved the motion by Board member Doug Willmarth, seconded by Board member Taylor Phelan, to approve the Financial Reports.

20-0376 Program Update

Chairman Hamilton called for the Program Update. Mr. Werner spoke about the Reopening roundtable, He and Mr. Jones will host since no businesses volunteered. Mr. Jones told the Board about the upcoming picnic planned for May 23, 2020. Main Street will host the Downtown Dine-out picnic on the square to encourage people to enjoy the restaurants downtown while also following social distancing guidelines. There will be additional picnic tables and music entertainment from 12:30-7:30pm. Mr. Werner updated the Board on plans to host a drivein movie night downtown, Main Street is purchasing an FM transmitter and researching which movies would be the best option. Mr. Jones explained to the Board the Sip N Stroll event coming up on June 20, hopefully this event will being people out to downtown. Ms. Rosenthal updated the Board on Oktoberfest 2020, not sure what it will look like yet, staff is working on lots of different scenarios to still bring people downtown, create revenue and provide entertainment, more information will be coming out as the state government announces the opening guidelines. We will need to form a sub-committee for Oktoberfest right away.

Discuss Strategic Initiatives including Mission and Vision

Chairman Hamilton called for the discussion of the Strategic Initiatives. Mr. Willmarth spoke to the Board, explaining the definition of Mission and Vision. Mission can be defined as Why do you exist? In the broadest possible sense. Vision can be defined as What you are doing. The Board discussed. Ms. Rosenthal introduced Mr. Mazzola to lead the Board through some processes for writing mission and vision statements for McKinney Main Street. Mr. Mazzola explained that a Mission Statement should be clear, specific, short and memorable, what is your core purpose, and what do you provide? Your Vision statement should be your North Star, where you are headed and should be short, concise, future-based, lofty goals, inspiring and motivational. The Board
