20-1002 City Liaison Report

McKinney City Council recently approved the architect firm that will begin working on the plans for the new city hall. Lake Flato Architects will begin design for a 13-acre site on the east side of Highway 5. Ms. Flomm discussed the topic of Parklets, this concept has been presented to Council and Council is willing to work with downtown restaurants to set up a parklet program. Ms. Flomm discussed the Throckmorton statue committee. The

committee has completed its study process and presented to Council.
