

## **MCKINNEY COMMUNITY DEVELOPMENT CORPORATION**

**MARCH 29, 2021**

The McKinney Community Development Corporation met in special session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Monday, March 29, 2021 at 8:00 a.m.

Board Members Present: Chairman Jackie Brewer, Vice Chairman Rick Glew, Secretary Mary Barnes-Tilley and Board members Kathryn McGill, David Kelly, John Mott and Deborah Bradford.

Board Member Absent: Board alternate Angela Richardson-Woods.

Staff Present: President Cindy Schneible and Administrative and Marketing Coordinator Linda Jones.

Chairman Brewer called the meeting to order at 8:00 a.m. after determining a quorum was present. She announced that today is National I'm In Control Day. Ms. Brewer's word for the day is "short," and she encouraged Board members to keep the meeting short. Board member Bradford provided an invocation, which was followed by the Pledge of Allegiance.

Chairman Brewer called for public comments on agenda items, and there were none.

**21-0256** Chairman Brewer called for consideration/discussion/action on the 2021 Quality of Life Award Nominations. She reviewed the voting procedures and stated that the vote would be made by a show of hands. She reminded Board members that a majority was needed to select awardees. Several Board members commented that with the quantity (31) and quality of nominations this year, the decision is difficult, emphasizing that McKinney is fortunate to have so many amazing residents making an impact on quality of life for all our citizens and visitors. Nominations for the Individual award were made by Chairman Brewer, Board member Kelly, Vice Chairman Glew, Board member McGill, Board member Bradford and Board member Mott. Chairman Brewer called for a vote. First-round votes resulted in a run-off between

two nominees. A second vote was held, and an individual was selected with a majority of votes cast. Nominations for the Organization award were called. A nomination was made by Board member Kelly. No other nominations were made. Board members unanimously selected the Organization/Project awardee. Chairman Brewer Chairman Brewer then announced the winners of the Quality of Life Awards. The Individual Quality of Life Award recipient is Kim Sanchez. The Organization/Project Quality of Life Award recipient is Feeding Friends and Family, a collaborative initiative between Alliance of Elite Youth Leadership, Community Lifeline Center and Mike Redeker.

Chairman Brewer called for a motion to adjourn. Board members unanimously approved a motion by Board member Mott, seconded by Board member Bradford, to adjourn. Chairman Brewer adjourned the meeting at 8:21 a.m.
