- Approval of Resolution.

ITEM SUMMARY:

- This Resolution authorizes a contract with Alliance Geotechnical Group to provide materials testing services during the construction of Stacy Road Lanes 5 and 6 (Custer Road to Ridge Road) Project (ST3212), for an amount not to exceed \$85,000.

BACKGROUND INFORMATION:

- A concurrent item is included on the Council Agenda recommending award of a construction contract for the Stacy Road Lanes 5 and 6 (Custer Road to Ridge Road) Project (ST3212).
- Material testing services will be required on the project to ensure construction materials used by the contractor meet or exceed City requirements.

- Alliance Geotechnical Group, Inc. submitted a response to RFQ 18-22 for miscellaneous geotechnical and materials testing services. They were one of five firms shortlisted by City Council on March 6, 2018.
- Alliance Geotechnical Group, Inc. has successfully performed in a similar capacity on numerous City projects.
- Alliance Geotechnical Group, Inc. has submitted a proposal for their professional services in the amount of \$72,238.00.
- Reimbursement for materials testing services provided will be made based on actual time and materials billing in an amount not to exceed the estimated proposal amount.

FINANCIAL SUMMARY:

- The Resolution authorizes a contract with Alliance Geotechnical Group for an amount not to exceed \$85,000.
- Funds are available in the Capital Improvements Program Project ST3212.
- With approval of this item and accompanying items for the Stacy Road Lanes 5 and 6 (Custer Road to Ridge Road) Project, \$195,951.45 will remain in ST3212.
