## **BACKGROUND INFORMATION:**

 Airport Master Planning is conducted in accordance with federal and State local requirements with input from the City and Business Leaders, Management and Staff and advisory committees made up of citizens and stakeholders. File #: 16-1056, Version: 1

- The main objective of the MPU is to provide a road map for efficiently meeting aviation demand through the foreseeable future while preserving the flexibility necessary to respond to changing business and industry conditions affecting McKinney National Airport.
- On February 3, 2015, City Council approved the conduct of a Master Plan Update (MPU).
- Recognizing a need to Master Plan McKinney National Airport, the Texas Department of Transportation, Division of Aviation, agreed to provide federal funding to conduct the planning effort.
- On October 28, 2015, Coffman Associates Airport Consultants of Lee's Summit, Missouri, was selected by a joint City and TxDOT evaluation team to conduct a 12-14 month Airport Master Plan Update (MPU).
- On July 21, 2016, Council named the Texas Department of Transportation (TxDOT), Division of Aviation as the City's agent to administer the MPU and authorized the City Manager to execute all contracts and agreements with TxDOT.
