ITEM SUMMARY:

- This Resolution authorizes a contract with Terracon Consultants, Inc. to provide materials testing services during the construction of the Virginia Parkway Lanes 5 & 6 construction project, for an amount not to exceed \$200,000.

BACKGROUND INFORMATION:

- Terracon submitted a response to RFQ 15-05 for Miscellaneous Geotechnical and Material Testing services. They were one of three firms shortlisted by City Council on March 3, 2015.
- Terracon has successfully performed in a similar capacity on numerous City projects.
- Terracon has submitted a proposal for their professional services in the amount of \$143,987.50.

FINANCIAL SUMMARY:

- The Resolution authorizes a contract with Terracon for an amount not to exceed \$200,000.
- Funds will be available in the Capital Improvements Program in ST1219/WA9145/ST1231 contingent upon approval of the corresponding budget item. \$92,000 will be available in project ST1219, \$8,000 will be available in project WA9145, and \$100,000 will be available in project ST1231.
- With approval of this item and accompanying items for the Virginia Parkway project, \$6,234.70 will remain in ST1219, \$3,043.20 will remain in WA9145, and \$5,293.40 will remain in ST1231.
