Staff recommends denial of the proposed rezoning request as Staff has concerns regarding
the ability to develop the property due to the extensive floodplain and the potential removal of
quality trees within the floodplain. A Tree Preservation Plan and a Flood Study will need to be
submitted to ensure the property can be developed for the requested townhome uses.
