RECOMMENDED CITY COUNCIL ACTION:

- Approval of application and acceptance of the U.S. Department of Justice 2017 Edward Byrne Memorial Justice Assistance Grant (JAG), if awarded.
- Authority to enter into an Interlocal Agreement and Memorandum of Understanding with Collin County and the City of Plano for disbursement of JAG funds.

ITEM SUMMARY:

- The JAG provides funds to assist in the enhancement of public safety and crime reduction in the City of McKinney.
- Funds will be used to purchase seven (7) tactical rifles for patrol officers.

BACKGROUND INFORMATION:

- The grant is issued by the U.S. Department of Justice to enable local law enforcement agencies to purchase needed equipment.
- The grant funds are shared by the City of McKinney, Collin County, and the City of Plano. The City of McKinney's share is \$12,023.

FINANCIAL SUMMARY:

- The cost of the equipment is approximately \$12,357. The grant will provide \$12,023. The remaining funds needed for the purchase will be funded by the Law Enforcement Budget.
