Conduct First Public Hearing on the Budget Appropriation Ordinance for FY 2017-18

### RECOMMENDED CITY COUNCIL ACTION:

- Conduct the first Public Hearing on the Budget Appropriation Ordinance for Fiscal Year 2017-18.
- Announce second Public Hearing & Budget Adoption: September 19, 2017, 6:00 p.m. at the Jack Hatchell Collin County Administration Building, located at 2300 Bloomdale Road, 4th Floor-Commissioners Court, McKinney, Texas 75071.

### ITEM SUMMARY:

- Proposed budget for all operating funds and CIP projects for FY 2017-18 total \$406.7 million.
- Proposed budget for component unit funds for FY2017-18 are as follows:
  - McKinney Convention & Visitors Bureau \$724,994
  - MEDC Debt Service Fund \$2,312,218
  - McKinney Economic Development Corp \$12,019,315
  - McKinney Community Development Corp \$11,251,740
  - McKinney Housing Finance Corp \$68,650
- The proposed tax rate is \$0.540199 per \$100 of assessed value. The proposed tax rate is over three cents lower than last year.

### BACKGROUND INFORMATION:

- The City Charter provides that “The City Council shall pass the appropriation ordinance in accordance with state law. Provision shall be made for public hearings upon the appropriation ordinance before the City Council”.
- The first public hearing on September 5, 2017 Council Meeting satisfies the Charter requirement.
- Following the first public hearing, the appropriation ordinance is to be published.
- A second public hearing must be scheduled at least ten days after publication.
- Any changes the Council wishes to make may be incorporated in the appropriation ordinance before the second public hearing and final adoption action by the Council to be held on September 19, 2017.
- **Budget adoption must be by record vote.**
- Following the second public hearing, and final adoption of the appropriation ordinance, the City Council shall consider and pass an ordinance ratifying the increased revenue from property taxes, an ordinance levying the taxes for the current year and an ordinance to change fees/rates for City services.

**SPECIAL CONSIDERATIONS:**

- **Budget Discussions** - Budget planning and tax discussions were held on July 31, 2017, August 4, 2017 and August 15, 2017.
- **Budget Ordinance** - Public hearings (September 5, 2017 and September 19, 2017) and vote to adopt the annual budget (September 19, 2017).
- **Ordinance ratifying the increased property tax revenue** - Ordinance and declaration (September 19, 2017).
- **Ordinance levying property tax rate** - Vote to adopt the ordinance levying the property tax rate (September 19, 2017).
- **Ordinance changing rates/fees for City services** - Adoption (September 19, 2017).
