### ITEM SUMMARY:

- This Resolution authorizes an award of a fixed price contract with Lawn Star Landscape of McKinney, Texas and DWW Landscaping, LLC of McKinney, Texas

### BACKGROUND INFORMATION:

- The City issued Invitation to Bid 18-25FP Mowing and Grounds Maintenance Services on January 14, 2018.
  - Advertised in McKinney Courier Gazette
  - Posted on McKinney TV
  - 231 eBid Supplier Notifications
- In response to all notices published, seven (7) bids were received on February 1, 2018.
- An evaluation team comprised of three Parks Maintenance staff members reviewed and ranked the bids based on the following criteria:
  - 50% Purchase Price

- 30% Reputation of the Bidder and of the Bidder's Goods or Services verified through reference checks
  - 20% Equipment
- The evaluation team recommends awarding Lawn Star Landscape the following:
  - Section A: Medians
  - Section A2: Right-of-Ways
  - Section B: Park Sites & Future Parks Sites, Line Item #6
  - Section C: Fire Stations & Public Safety
- Additionally, the evaluation team recommends awarding DWW Landscaping, LLC the following:
  - Section B: Park Sites & Future Parks Sites, all Line Items with the exception of Line Item #6.
- Contract will commence on date of award and continue for a one (1) year period with two (2) one (1) year renewal options.

**FINANCIAL SUMMARY:**
