  first Alternates appointed for service beginning October 2019, serving for two years until October
  2021 or until their successor is appointed; and the second of the Alternates appointed for service
  beginning October 2019, serving for one (1) year until October 2020 or until their successor is
  appointed.
- Boards with one Alternate will have members appointed for a two-year term beginning in October 2019 serving until October 2021 or until their successor is appointed.
