- The Texas Chapter of the APA has presented the City of McKinney with an Award for Planning Excellence for the ONE McKinney 2040 Comprehensive Plan.
  - This award recognizes comprehensive plans that advance the science and art of planning.

- Two cities received this award for their comprehensive plans, the City of McKinney and the City of Boerne.
- Additionally, the Texas APA has awarded the City of McKinney with the "Certificate of Achievement for Richard R. Lillie, FAICP Program for Planning Excellence."
  - This award recognizes the professional planning standards demonstrated by planning staff and the support exhibited by the City Council and Planning and Zoning Commission.
  - o In order to receive this award, a city must meet the APA Chapter goals for:
    - Increasing awareness of professional planning;
    - Enhancing neighborhood and citizen recognition of planning efforts;
    - Encouraging the funding of professional training for commissioners and staff;
      and
    - Aiding economic development and community image.
  - The City of McKinney has received this recognition eighteen (18) of the past nineteen (19) years.
  - This year, 40 communities in Texas received this award.
