### ITEM SUMMARY:

- This Resolution authorizes the City Manager to execute a professional services contract to provide architectural and engineering (A/E) services related to the completion of design and construction of TKI Executive Terminal located at 1508 Industrial Blvd, McKinney, Texas.

### BACKGROUND INFORMATION:

- CaCo is a professional architectural consulting firm based in Dallas and has been the architect

of record on multiple successful similar projects for municipalities including the McKinney National Airport.

- CaCo has submitted a proposal to provide professional architectural and engineering services for the design & completion of the TKI Executive Terminal for a lump sum fee of \$199,717.

**FINANCIAL SUMMARY:**

- The TKI Executive Terminal project is included in the FY20 Capital Improvements Program plan and funds are available in AI1744.
- This Resolution authorizes the City Manager to execute a professional services contract for architectural and engineering services, including potential changes to the scope of services, with CaCo Architecture, LLC for an amount not to exceed \$219,717 which includes a contingency amount of \$20,000.
- Upon approval of this item, \$685,637.95 will remain in AI1744.
