CITY COUNCIL WORK SESSION

JUNE 4, 2024

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, located at 222 N. Tennessee Street, McKinney, Texas on Tuesday, June 4, 2024 at 3:00 p.m.

The work session was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at https://mckinneytx.new.swagit.com/views/130. A video recording of the meeting is available to members of the public through the City of McKinney meeting archive.

Mayor Geroge C. Fuller called the meeting to order at 3:00 p.m. upon determining a quorum consisting of himself and the following City Council members were present: Mayor Pro Tem Charlie Philips, and Council members Justin Beller, Patrick Cloutier, Geré Feltus, Rick Franklin, and Michael Jones.


Easements

Utility Easement: – A grant of specific legal rights to utility on a property for the installation, operation and maintenance of utilities.

- Typically located along property lines or within specific areas of a property as designated by legal agreements or property deeds.
- Provide access for maintenance and repairs of utilities.
- Require periodic maintenance including vegetation removal.

1. Total Assets

- Sewer Mains 791 miles
- Sewer Manholes 15,995 manholes
- Water Mains 1,121 miles
- Water Valves 35,000 valves

2. Assets Located "Off-Site"

- Sewer Mains 52.8 miles
- Manholes 1,000+ manholes
- Water Mains 9.47 miles
- Water Valves 134 valves





Purpose For Off-Site Utility Maintenance Program

- Provide access to critical infrastructure in both routine and emergency situations.
- Remove trees.
- Make repairs to existing infrastructure.
- Install and upgrade new infrastructure.
 - Deliver critical services to residents.















Challenges Of Off-Site Utility Maintenance Program

- Resources and growth Cycle of off-site maintenance is not consistent.
- Residents perceive the task as damaging nature and areas near their properties.
- Resident misunderstanding of easements.
- Overflows can become more severe due to limited access.

Recent Service Delivery Challenges

Challenges

- Waste Connections labor shortage
 - Lack of qualified CDL Drivers
 - Contract ending October 1, 2024
- Delays in solid waste collections
- Prioritization:
 - Garbage
 - Recycling
 - Yard Waste

City Response

- Enforcement of contract provisions with Waste Connections
- Engagement with Waste Connections for service improvement
- 3. Discussions with Frontier and Waste Connections on a "tapered" transition



Cart Purchase Process



- RFP Issued December 11, 2022 -Included purchasing of carts
- City Council authorized contract with Frontier Waste Solutions on August 15, 2023, which included the purchase of 95-gallon carts with the City retaining ownership
- Budget amendment (\$7M) \$54 per cart




New Color & Technology



- 131,000 Carts Manufactured by Rehrig (Dallas)
- All carts are 95-gallons
- Colors:
 - Trash Dark gray
 - Recycling Navy blue
 - CBD Cart Black
- RFID chip & barcode to link carts to address





Cart Delivery Schedule

- Program will run between
 May 28 and July 19
- Residents carts will be exchanged on <u>one</u> of the trash days between this timeline

Cart Replacement Process

- Step 1 Residents put out garbage on trash day
- Step 2 New carts delivered on trash day (quantity based on current bill)
- Step 3 Garbage is picked up from old carts
- Step 4 Residents move new carts
- Step 5 Old carts picked up same day

Cart Removals





Exceptions / Outliers / Missed Carts

- Residents requested to leave old carts out until picked up
- Residents are directed to submit online cart order form for extra cart deliveries & removals
