Bids were received for the 24-55CC ALCMS Installation project at the City of McKinney Purchasing Department at 2:00 PM on June 6, 2024. The bids have been checked for accuracy and for compliance with the contract documents. A tabulation of the bids received is enclosed with this letter.

A total of three (3) bids were received on the project. Vellutini Corp dba Royal Electric submitted the low bid for the project in the amount of **\$294,000**. The Engineer's Opinion of Probable Cost for the project was **\$381,750**. The table below outlines the costs for each received bid.
