The Planning and Zoning Commission of the City of McKinney, Texas met in regular session in the Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, June 25, 2024 at 6:00 p.m.

Chairman Cox called the meeting to order at 6:00 p.m. after determining a quorum was present.

Chairman Cox continued the meeting with the Regular Agenda Items and Public Hearings on the agenda.

Jennifer Arnold, Director of Planning for the City of McKinney, stated that Staff recommends that the item be tabled and the public hearing continued to the July 9, 2024 Planning and Zoning Commission meeting due to the notification signs not being posted on the property by the timeframe required by the Zoning Ordinance. Chairman Cox opened the public hearing and called for comments. There being none. On a motion by Vice-Chairman Lebo, seconded by Commission Member Buettner, the Commission unanimously voted to continue the public hearing and tabled the request until the July 9, 2024 Planning and Zoning Commission Member as recommended by Staff, with a vote of 7-0-0.

Chairman Cox opened the public hearing and called for comments. There being none, on a motion by Vice-Chairman Lebo, seconded by Commission Member Wattley, the Commission voted to close the public hearing, with a vote of 6-1-0. Alternate Commission Member Hammack voted against the motion. The Commission Members discussed their concerns. On a motion by Commission Member Taylor, seconded by Commission Member Buettner, the Commission voted to deny the request as recommended by Staff, with a vote of 6-1-0. Commission Member Conrad voted against the motion.
