**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
McKINNEY, TEXAS, APPROVING THE FY 2026 COMMUNITY
SUPPORT GRANT FUNDING ALLOCATIONS, AND PROVIDING
AN EFFECTIVE DATE**

WHEREAS, the City Council established the Community Support Grant to support direct funding assistance for qualifying non-profit agencies serving the City of McKinney and its residents; and,

WHEREAS, the Community Grants Advisory Commission for the City of McKinney received grant applications from qualifying non-profit agencies; and,

WHEREAS, the Community Support Grant budget includes funding to qualifying non-profit agencies and city administered programs; and,

WHEREAS, the Community Grants Advisory Commission held two public hearings and two public meetings to prepare recommendations for Council acceptance of the use of Community Support Grant funds; and,

WHEREAS, the City Council of the City of McKinney, Texas, finds and determines funding for the following qualifying programs that accomplishes a public purpose and municipal purpose for the City of McKinney.


