

# **Executive Summary**

# AP-05 Executive Summary - 24 CFR 91.200(c), 91.220(b)

### 1. Introduction

Format and language of the document is as required by The U.S. Department of Housing and Urban Development (HUD). The City of McKinney is a grantee recipient of Community Block Development funding. HUD regulations at 24 CFR Part 91.15(a)(2) requires the city to submit an Annual Action Plan by August 16, 2019 to receive estimated funds under the PY 2019-2020 program year. The Annual Action Plan details how funds will be used to address the goals and objectives within the City's Five Year Consolidated Plan (2015-2019). The PY 2019 Action Plan represents the fifth year under the Consolidated Plan process, to include the assigned allocation of \$ 761,993. The Housing and Community Development Department is the lead department responsible for the consolidated planning process. The development of the Annual Action Plan involves collaboration with multiple stakeholders including, residents, city departments, social service providers, organizations, housing developers, small business owners, and the general public. Responses under the action plan are based on requirements and format of HUD.

The Community Development Block Grant Program (CDBG) requires that each funded activity must either principally benefit low and moderate income persons and households, aid in the prevention or elimination of slums and blight, or met a community development need having a particular urgency. With respect to impacting residents in a given area, at least 51% of McKinney's area residents must be of low and moderate income. Funded agencies and city program primarily must meet this requirement.

However, given the location of the City within Collin County, some areas may have great need, but may have no or few areas in which 51% of the residents are low and moderate income. As such, the CDBG law, per the U.S. Department of Housing and Urban Development (HUD) authorizes an exception criterion in order for the City of McKinney to broaden program reach and undertake area benefit activities. The exception threshold for each based on the 2011-2015 American Community Survey (ACS). This percentage of 45.80% under FY 2019 represents the minimum percentage of low- and moderate-income persons that must reside in the service area of an area benefit activity for the activity to be assisted with CDBG funds, if the City proposes use of area benefit activities during the program year.

Under law, Section 105 (c)(2)(A)(ii) is implanted in the CDBG regulations at 24 CFR 270.208(a)(1)(ii), which identifies the exception threshold: all block groups within the grantee's jurisdiction in which people are residing are order ranked from the highest percentage of low-to- moderate income persons to the lowest. The total number of block groups is divided by four. If the percentage of low and

moderate income-person in the last block group in the top quartile is less than 51 percent, that percentage becomes the grantee's low and moderate income threshold for area benefit activities.

# 2. Summarize the objectives and outcomes identified in the Plan

The City developed its CDBG objectives and outcomes for the 2019-2020 Program year of the Action Plan based on citizen participation and needs identified in the Consolidated Plan. Proposed funds used will continue to assist persons preserve affordable housing under housing rehabilitation and other resources, assist the homeless and those at-risk of homelessness, provide public services including but not limited to senior citizens, youth, abused or neglected children and further fair housing.

## Decent Housing

 Goal of providing direct assistance of Housing Rehabilitation repairs for 15 homes, including substantial rehabilitation; Tenant-based rental assistance for 5 households; (State funding), two applicants for homeownership and provide homeless prevention resources by providing 10 housing choice voucher holders with security deposits and assisting at minimum 20 eligible households with emergency rental, utility or mortgage assistance.

# A summary of resources for use in public services

Through CDBG funding, the city will partner to provide homeless and shelter supportive services for approximately 75 persons; academic support services for 45 students; Volunteer advocacy services and training to assist approximately 30 abused or neglected children; counseling services; meal service to assist senior citizens; support to help residents with security deposits toward affordable housing

Under CSG funding, public services will include the leveraging of city grant funding to assist with support of affordable housing; services for abused spouses; life-skills management for youth; healthcare to persons underinsured or uninsured; program services for at-risk youth to develop strong academic and social skills and support to veterans to ensure improvement with housing and support services.

### 4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

The citizen participation process includes at least two public meetings/hearings and a public comment period for citizens to provide feedback on proposed plans. Participation also includes public comments, community forums of the anticipated funding and the application process. The city works with city departments, service providers, agencies and interested persons to implement the Annual Action Plan goals and strategies. The city will continue the formal structure to administer CDBG funds and continue informal communication and coordination with governmental and non-governmental agencies to meet housing assistance needs and support needs of low to moderate income persons and households. The city will work to eliminate gaps when possible and continue to emphasize service delivery needs for federal, state and local programs. Technical assistance began with a grant announcement that was published in print and distributed through social media networks. Interested persons and agencies were asked to attend a pre-application meeting in March, 2019 to learn directly about requirements.

Applicants received technical assistance by phone, email or in-person consultation for the grant application process before the grant deadline submission. City staff reviewed applications for compliance of grant deadlines and requirements, and prepared materials under public hearings held by the Community Grants Advisory Commission. The Commission – a 7 person voluntary group, appointed annually by City Council - serves as the citizen participation group to conduct public hearings, review applications and provide funding recommendations to City Council. Public hearings were held to hear funding requests of activities and city programs under the Annual Action Plan. Notices are posted on the city's website, emailed through newsletters to the public and announcements made to community groups and coalitions.

Citizens are able to provide their input at three public meetings, three public hearings and written comment during the public comment period. The City provides public notice regarding the public comment period and meetings through publication in the newspaper, department social media newsletter, and other means of announcement. All public hearings are posted on the board at McKinney City Hall and at the website, **http://www.mckinneytexas.org**. The following a list of public hearings, meetings and comment periods that afforded citizens opportunity to provide input and engage in the process of the 2019-2020 Annual Action Plan:

- Pre Application Public Meeting for the Consolidated Grant Process, February 28, 2019
- Public Hearings: May 8, May 9, 2019
- Notice of public comment period: July 5– August 6, 2019

• City Council Public Hearing: August 5, 2019

Notices were published in the local newspapers and on the city's website. The Action Plan is made available for viewing at the Housing and Community Development Department office during business hours, online and by direct mail, as requested. Actions carried out or supported through implementation of the FY 2019-2020 plan are a direct result of discussions where City staff have participated and out of ideas, testimonies the City may have received through formal processes.

# 5. Summary of public comments

# AP-10 Consultation - 91.100, 91.200(b), 91.215(l)

### 1. Introduction

Citizen engagement is an important process under the Community Development Block Grant. It includes input from citizens, non-profit and community organizations, social service support organizations, the Collin County Continuum of Care and other stakeholders to identify priorities and needs for the Consolidated Plan. The city also consulted with participants of the Collin County Homeless Coalition, Metro Dallas Homeless Alliance, Collin County Social Services Association, citizens citywide, the neighborhood P.R.I.D.E. *(Promoting Residents, Involvement, Development, and Enthusiasm)* Community Group, McKinney Housing Authority, and other innumerable agencies. Through the Housing & Community Development Department, the city also engages maintains close contact with its own Community Support Grant and CDBG subrecipients that serve McKinney Residents.

In the city's citizen participation plan, the city hosts at least three public hearings per year to discuss the priorities, processes and evaluation of the CDBG and CSG programs. The Community Grants Advisory Commission – a 7 person citizen voluntary group appointed by Council – meet to discuss proposed funding for the programs and provide recommendations to City Council. The city maintains informal and formal contact with agencies and the public throughout the year through public meetings, forums and reporting.

# Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I))

The City of McKinney works closely with the Collin County Continuum of Care, P.R.I.D.E., Collin County Social Services Association, the Collin County Homeless Coalition, the Collin County Veterans Coalition; North Collin County Habitat for Humanity, the McKinney Housing Authority, and other stakeholders to coordinate strategic initiatives to learn and determine where housing, social services, health and community development needs. Efforts work together to identify priority needs, provide outreach, share knowledge and funding opportunities with providers and interested persons.

# Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

The City of McKinney has been an active member of the Collin County Homeless Coalition since its inception in 2004, which is comprised of Collin County municipalities along with service providers, educators, faith-based and community organizations, businesses, formerly homeless persons and other interested parties who are charged to address the goal of meeting housing, health and social service needs of the chronically homeless, veterans, at risk runaway or foster youth, families with children and other homeless or at risk for homeless populations.

The City consults with the Metro Dallas Homeless Alliance (MDHA) through the Collin County Homeless Coalition to conduct the annual Point-in-Time Count each January to determine the number of homeless in the city and capture data for service needs and outcomes. MDHA has a Coordinator that services McKinney residents and Collin County residents with support to seek social services and housing. The McKinney downtown library provides office space at least one day a week to support outreach efforts. The McKinney Police Department hired an officer, in the role of serving as homeless liaison to support efforts of the count, resident concerns, assist in coordination of needs for those who are homeless and also attends monthly county-wide coalition meetings.

The mission of CCHC is to work together to develop solutions to homelessness in Collin County. The CCHC also works under Metro Dallas Homeless Alliance as they implement their work plan under Core objectives - progress to end chronic homelessness; increase housing placement and stability; increase household employment and benefit income; increase progress to end family homelessness; improvement of coordination, collaboration and partnerships; improve information and knowledge on homelessness; and measuring success and performance.

Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS.

The city does not receive ESG funds at this time. The City has applied for funds under the Texas Department of Housing and Community Affairs (TDHCA) as a subrecipient to provide street outreach services to those that are homeless. The application and review process is still in progress at this time. The City's Consolidated Plan includes the priority of serving the homeless and those at-risk of homelessness and therefore, no substantial amendments were required for this category. If awarded, the funding may be provided during the program year.

HUD provides funding under the Emergency Shelter Grant (ESG); grantee recipients and subrecipients use funds to rehabilitate and operate transitional shelters, provide essential social services, street outreach and other services to reduce the impact of homelessness.

#### Introduction

With a population of more than 180,000 residents, the City of McKinney anticipates approval under the U.S. Department of Housing and Community Development's CDBG program to receive funds for use under the program year of October 1, 2019- September 30, 2020. Entitlement communities receive annual funds to carry out housing and community development activities to revitalize neighborhoods, leverage service resources and meet local needs. The City has an allocation \$ 761,993 in CDBG funds for PY 2019 and anticipates carryover funds unused from previous year(s) to be used toward eligible activities including housing rehabilitation, vacant lot acquisition, other community and economic development activities. Other federal resources that may be available to McKinney residents through organizations include funds from Choice Vouchers separately under the McKinney Housing Authority; Tenant Based Rental Assistance Funding and Homebuyer assistance funding through the city (only if available and awarded from TDHCA state funds, Community Support Grant funds, Low-Income Housing Tax Credits (LIHTC), if applied and awarded. Programs are available either directly to low to moderate income households and persons.

# Explain how federal funds will leverage those additional resources (private, state and local funds), including a description of how matching requirements will be satisfied

The City of McKinney seeks to ensure CDBG funds are used to maximum effectiveness within regulatory and statutory limitations, cost reasonableness, leveraging and evaluation in its competitive application process. Federal funds leverage scope of local funds to expand housing and community development services directly to McKinney residents and households. Local organizations must submit a detailed application demonstrating the project will meet a CDBG National Objective, meet criteria for eligibility activities, have organizational capacity to meet local and federal requirements, and at minimum one priority under the city's Consolidated Plan. There are no matching requirements for CDBG.

The City leverages additional resources for housing and community development through TDHCA funding, if awarded and the Community Support Grant Funds are determined annually by City Council for the Support Grant. CDBG sub recipients must also indicate that other leveraged resources that may include state, local, corporate or private funding are among applied or confirmed resources to implement said program. Funding may be used for program costs, salaries, program supplies and materials among other eligible costs.

Agencies unable to meet capacity of federal reimbursable grant may apply to use local funds under the Community Support Grant, to provide direct needed services. Organizations may apply for Community Support Grant funds each fall, to be used for program costs, salaries, supplies and materials toward the benefit of serving McKinney residents. Applications and evaluation criteria are reviewed both by the Community Grants Advisory Commission and primarily funding support benefit households or persons in the areas including housing support, emergency financial assistance, education/literacy, mental health counseling, youth services, senior services, supportive housing services, or health care. Agencies and city programs will be required to submit progress and financial reports of funding use. Agencies approved for CDBG funds in the same year will be ineligible to apply for the same program. HOME funds awarded by the state will support eligible McKinney residents under the Tenant Rental Based Assistance Program, where residents will be assisted for up to 24 months with rental and utilities for low to very low income persons, including those in transition of being sheltered at the Samaritan Inn.

## Discussion

Tenant-Based Rental Assistance and the production of new units will come from state funding, as available and awarded through Texas Department of Housing and Community Affairs (TDHCA) to assist 5 residents. Other goals will be achieved through CDBG funding to assist homeless residents with case management services and an estimated 15 households with emergency rental assistance. CDBG cannot be used for the development of new housing units. Where there is need, upon evaluation the city will seek consideration of the Housing Finance Corporation to assist families in need to develop a housing unit and will be reported in the city's year-end report of outcomes and accomplishments.

# AP-60 Public Housing – 91.220(h)

# Introduction

The Housing Authority of McKinney, MHA, is an independently run entity, which receives funding and monitoring directly under the U.S. Department of Housing and Urban Development. MHA owns and operates public housing units and administers the Housing Choice Voucher program. This program assists very low income families, the elderly and this disabled to afford housing in the private market. Participants are able to choose any housing within a 50 mile radius that meets requirements of the program and housing is not limited to units located in subsidized housing projects. Rental units must meet minimum health and safety standards. A housing subsidy is paid to the landlord directly on behalf of the renter, the family then pays the difference between the actual rent charged by the landlord and the amount subsidy. Housing Authority of McKinney operates 201 affordable units across its public housing portfolio. The bedroom sizes of Housing Authority of McKinney public housing units range from 1 bedroom apartments to 3 bedroom apartments. The housing authority's public housing inventory includes:

37% - 1 bedroom apartments; 38% of the units are two-bedroom apartments and 25% of the units are 3-bedroom apartments.

Of the public housing residents residing in Housing Authority of McKinney properties, 141 were Extremely Low Income, 36 were Very Low Income, 8 were Low Income and 1 were Above Low Income. The average annual income of public housing residents living in Housing Authority of McKinney properties is \$12,849. Of all public housing residents, 3% have no income and 11% earn more than \$25,000 while 86% have incomes that fall between \$0 and \$25,000.

The Housing Authority will work in partnership with the city to seek input and update the Analysis of Impediments for Fair Housing Choice and as a lead partner under the city pilot program, LIFT to assist Housing Choice Voucher holders. The McKinney Housing Authority is currently working toward completion of the redevelopment of Merritt Homes, which began reconstruction under the last program year. As a partner, the City and MHA continue work in outreach to engage residents on fair housing and other programs, including Homeownership and Tenant Based Rental Assistance or referrals for public services, when applicable.

## Actions planned during the next year to address the needs to public housing

As with housing authorities and providers across the country, MHA also faces the challenges of leasing, maintaining units due to the aging stock of the public units and the severe backlog of capital needs. MHA is a participant of the Rental Assistance Demonstration program (RAD) to preserve public and HUD-assisted housing units through conversion. The first units that were redeveloped included Newsome Homes, completed May 2017. MHA is underway in the redevelopment of Merritt Homes at

1200 N. Tennessee Street and anticipates completion by December, 2019. This will be the second successful reconstruction of the housing units, now structured to provide eligible residents with housing units that provide greater comfort, energy efficiency and a community room. MHA submitted application to HUD for a RAD PBRA conversion for the current 86 housing unit facility to be redeveloped to 136 units (86 PBRA and 50 Tax Credit units). In an effort to deconcentrate, MHA sought to partner in developing a portion of the 86 PBRA units in a qualified high opportunity area in McKinney, but did not receive response to the RFP.

### Relocation Plan.

McKinney Housing Authority is responsible and will authorize a preference to the Housing Choice Voucher and PBRA waitlist in the event a participant is displaced due to RAD. Per MHA's action plan, "MHA will offer a Waiting List preference to families that must temporarily relocate from Merritt Homes as a result of the planned demolition of the site and its subsequent redevelopment via RAD program. The family will qualify for the preference if the household has been issued a General Information Notice and has not already taken occupancy of a different temporary placement. MHA will permit voluntary transfers from properties scheduled to the RCC if the tenant requests."

The relocation plan continues to prove successful and eligible residents will be continue to be under the plan, per RAD program requirements during the program year.

# Actions to encourage public housing residents to become more involved in management and participate in homeownership.

The McKinney Housing Authority encourages resident to become more involved in their environment through volunteerism, school activities, and participation under the Resident Council program and also the city's programs including Neighborhood Services, citizen input meetings and committees. Residents are aware and encouraged to attend public education programs for homebuyers conducted by the city's Library and Housing and Community Development departments.

# If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

The U.S. Department of Housing and Urban Development (HUD) requires determination. Based on review information at this time, The McKinney Housing Authority (MHA) is not designated as troubled.

# AP-65 Homeless and Other Special Needs Activities – 91.220(i)

# Introduction

The Annual Action Plan also includes activities that support Consolidated Plan areas. The Salvation Army and Community Lifeline Center will be the only CDBG funded agencies this year providing homeless prevention assistance. The city's Tenant Based Rental Assistance Program receives funding through the state of Texas, to assist eligible residents with rental and utility assistance for up to 24 months toward self-sufficiency. The city will be in its 2<sup>nd</sup> year of this \$200,000 grant. It's anticipated approximately 5 households will be served during the program year.

# Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including: Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

General goals including to assist homeless persons and families in the Continuum of Care, cycle of homelessness, and homeless prevention; providing street outreach resources and conducting programs under public services.

- *Homelessness Prevention:* Prevent homelessness by providing emergency assistance including rental, mortgage and utility resources, with outreach and supportive education to at-risk households.
- *Homeless Public Services:* Support public services and rental assistance help and transition homeless families, persons or at-risk youth to gain employment and life-skill resources that support self-care and sufficiency.

## Addressing the emergency shelter and transitional housing needs of homeless persons

*Homeless Housing:* Support impact of housing for the homeless, including transitional housing, emergency housing and permanent housing with supportive services for the chronically homeless. The City continues to partner with the Samaritan Inn for meeting transitional housing resources of the community. Other agencies such as City House will meet emergency shelter needs for youth with funding from the city's Community Support Grant.

Each year, the city leads an annual Point-in-Time count of unsheltered persons in January to within the program year, the city will update its Consolidated Plan to review community needs in addressing emergency shelter.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals

and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

### Discussion

Those who are at-risk of homelessness will have access emergency housing assistance for utility, rental or mortgage assistance from agencies including Community Lifeline Center and the Salvation Army. The city provides assistance for those at risk of homelessness under water shut-offs by providing a grant to assist the very vulnerable, which includes senior citizens and the disabled.

A new pilot program called LIFT will assist those at-risk of homelessness under use of vouchers. The positive, effective engagement with Collin County Landlords will be critical in assisting low-to-moderate income renters – particularly 50% and below of the area median income mitigate conditions due to the lack of available and reasonable housing, which aids in creating at-risk conditions for homelessness. In partnership with the McKinney Housing Authority, LIFT will provide homeless prevention resources for those who are low-income and aid in reducing the administrative burden under the housing authority.

# AP-75 Barriers to affordable housing – 91.220(j)

# Introduction:

The city supports housing initiatives benefiting all McKinney residents toward affordable options that best fit any income, including low to moderate income households. The city does not have codes or regulations identified as regulatory barriers to affordable housing. The City of McKinney and McKinney Housing Authority are working toward development and participation of a regional plan with local input.

# Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

Promote Public Education: The City will continue work to hold community conversations and workshops to provide insight into concerns under communication of projects between residents and developments with neighborhoods and provide city liaison access between neighborhood groups including P.R.I.D.E. (Promoting Resident Involvement, Development and Enthusiasm. Coordination will include four community meetings during the year and work in concert with public hearings as city prepares to update the Comprehensive Plan.

Resource supporting Accessible Housing Units: The Housing and Community Development Department will continue to be a resource for the City with local developers and builders regarding housing accessibility requirements regarding compliance and when possible, use CDBG funds to collaborate with organizations including the North Texas Fair Housing Resource Center and North Texas Aging and Disability Center to provide residents, apartment providers, contractors and architects on Fair Housing Act accessibility requirements.

Education for Future Homebuyers: The City will continue partnership engage resources to provide education to first-time homebuyers and any interested persons who want to learn about all facets in responsibilities and knowledge on fair housing rights and watch against predatory lending practices as they seek the path to homeownership. Workshops are held during program year.

# AP-85 Other Actions - 91.220(k)

### Introduction:

McKinney will undertake actions to address Underserved Needs; fostering and maintaining affordable housing; reducing lead-based paint hazards; reducing poverty-level families; developing institutional structure and enhance coordination between public and private agencies.

### Actions planned to address obstacles to meeting underserved needs

The City will review the Consolidated Plan 2015-2019 and consider priorities for CDBG allocations that were met and conduct the next Consolidated Plan for 2020-2024. Resources to improve understanding of community needs and data. The citizen participation plan will include public meetings, surveys, consultations, hearings and workshops, as well as analyzing and updating data. City staff will continue to participate in Collin County Homeless Coalition, citywide neighborhood and community meetings, Collin County Social Services Association, Wellness and Health Alliance, and other resources to learn about trends, available services and advise the Community Grants Advisory Commission.

City will also continue implementation, resource enhancement and training under the Transition Plan for compliance and impact for resident needs under instruction from the ADA Coordinator and federal requirements. Other obstacles to meet underserved need include the uncertainty of adequate funding. The actual amount of the CDBG allocation varies from year to year and influences are beyond the City's control. The City continues to research and apply for additional sources of funding.

### Actions planned to foster and maintain affordable housing

- Connecting with residents and other stakeholders under our citizen participation plan to seek
  their input to foster and maintain affordable housing. Public hearings, focus groups and meetings
  were conducted in the previous program year and that work will continue in the program year.
  Work with interested developers and community partners on potential affordable housing
  developments. The City will work to make developers aware of provisions within the city's housing
  policies for developments inclusive of affordability for working individuals and families. Staff will
  also continue to research incentives and programs to promote preservation of affordable housing
  in all areas of McKinney. Continued implementation and development to meet current goals
  and update the Analysis of Impediments for Fair Housing. The city continues to coordinate
  planning and engaging the public in the process to develop programs, incentives and public
  education based on the analysis and address goals and strategies of housing barriers.
- The city will also continue working with affordable housing service providers on public education and events to promote Affordable Housing. Staff continues to work with service providers to promote housing resources at a regional level and will expand to plan Housing Fairs. The fairs will focus on housing related topics including planning impacts, grant assistance, fair housing, tenant/landlord rights and responsibilities, first-time home buyer assistance, tenant-based rental

assistance and other needs. Ongoing assessment and updates to housing policies and affordable housing assistance materials will be conducted through the updating the city's Consolidated Plan and Analysis of Impediments, including meeting with neighborhood and community stakeholders for input.

McKinney also is now a participant of the SETH - The 5 STAR TEXAS ADVANTAGE PROGRAM
provides eligible homebuyers several options for a loan program that meets their needs. This
program provides down payment and closing cost assistance in the form of a gift. The maximum
amount of assistance provided is 5% of the loan amount. There is no repayment expected for
this Grant. For homebuyers, this reduces their out of pocket expense and makes home
ownership obtainable. Grant funds can be used to meet the buyer's required investment. Loan
terms for both options are fixed 30 year rates.

### Actions planned to reduce lead-based paint hazards

Lead-based paint regulations will be followed for rehabilitation projects for units constructed before 1978, including testing as required. As required if lead-based paint is found present, contractors certified in safe work practices will be used for abatement as required by HUD and the state of Texas.

If children under the age of 6 live in the housing unit they will be referred to the Health Department for testing for lead-based paint exposure. Clearance tests will be performed by a certified risk assessor and a certified laboratory when project is complete. All CDBG-funded projects will take potential presence of asbestos into consideration. Assessing the need for lead-based paint remediation will be considered and undertaken as needed for all CDBG-funded housing rehabilitation projects; Most of the potential Lead-Based Paint hazard are restricted to the older areas in McKinney where housing stock pre-dates 1978. This area primarily is bounded east of Highway 5. Census data indicates there could be as many as 2600 households that may be at risk of exposure. The City will pay attention to monitoring rehabilitation projects in these areas. Under this program year, there will be greater emphasis to continue public education to encourage participants to seek program resources available.

### Actions planned to reduce the number of poverty-level families

According to census data, more than 8% percent of McKinney residents are at the poverty-level, and nationally poverty impact for children 18 years and under continue to increase. McKinney will implement the following strategies based on consultation with the community in program year: Neighborhood Community Development – Continue to work with the McKinney Police Department, affordable housing providers and other support services to support enhancement community policing or neighborhood-based programs for improvements and engagement. Affordable Housing –The city will preserve affordable housing with CDBG and state funding to assist applicants under the housing rehabilitation program. Citizens will continue to receive homeownership and fair housing education through public education programs and renters will gain access to first-time homebuyer and closing costs grants through state funding.

Youth Services - Work to provide funding for agencies assisting low-income youth, including afterschool, job training, and academic or mental health counseling programs. Funding will be provided to Community Lifeline Center and the Salvation Army to assist families with emergency rental and utility assistance to prevent homelessness. A CDBG public services grant will be given to Communities in Schools to assist a great need at Caldwell Elementary to assist students with enhanced academic counseling. CASA of Collin County will provide court-appointed volunteers to assist abused/neglected children with case management services.

### Actions planned to develop institutional structure

The city will work with city departments, service providers, agencies and interested persons to implement the Annual Action Plan goals and strategies. The city will continue the formal structure to administer CDBG funds and continue informal communication and coordination with governmental and non-governmental agencies to meet housing assistance needs and support needs of low to moderate income persons and households. The city will work to eliminate gaps when possible and continue to emphasize service delivery needs for federal, state and local programs. Ongoing efforts will continue to participate in community partnerships, to learn and provide share exchanges of program successes.

# Actions planned to enhance coordination between public and private housing and social service agencies

The City engages coordination and collaboration between public and private housing and social service agencies, the City works with subrecipient agencies listed in the summaries, as well as agencies funded through City funded Community Support Grant. City staff provides support and information updates to the Community Grants Advisory Commission. The City also works with organizations to further enhance services and information including, but not limited to Collin County Social Services Association; Collin County Homeless Coalition; Collin County Veterans Coalition; and Volunteer McKinney, among others.
