The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, Tuesday, August 6, 2024 at 6:00 p.m.

Approving the 2024-2025 Annual Action Plan and the Substantial

Amendment to the 2020-2024 Consolidated Plan

Ms. Best gave a presentation related to the Community Development Block Grant (CDBG) funding. She stated anticipated funding in the amount of \$912,415.00 will begin October 1; and due to the performance, need assessments and participation within the City, Housing and Community Development is now eligible to be a Housing and Urban Development (HUD) participating jurisdiction which will provide additional funding known as Home Grant Funds. She specified the funding, stated for the record, will be exactly three hundred forty-six thousand three hundred forty-two dollars and eighteen cents (\$346,342.18) and by regulation a match of funds is required; a match in the amount of one hundred fifty-four thousand five hundred ninety-one dollars (\$154,591) was received from the Texas Department of Housing and Community Affairs (TDHCA). She stated the Community Grants Advisory Commission (CGAC) began the Consolidated Grant Application process in February which allows for the commission to review funding recommendations to be presented to the Council, which also includes city administered funds. She stated although funding is not approved until the fiscal year budget has been approved, this process is required by regulation through HUD which includes this public hearing. She indicated the CGAC has hosted one information session, three public hearings and two public meetings for public input; and are currently under a thirty (30) day public comment period that will conclude August 14. She indicated an inquiry for financial support has been received, and to state for the record, all CDBG grants are monitored, are fiscally sound and that all agencies are reviewed not only for audits but their submissions to tax records and other resources. She stated occasionally an agency may have funding recommendations they are not required to receive or accept those grants; and with recommendation of the CGAC the Agency Family Gateway is officially withdrawing their proposed recommendation in the amount of twenty-two thousand three hundred twelve dollars and fifty cents (\$22,312.50). She stated, for a matter of record,

the application submission will be declined by their request and the CGAC does not lose the funding, but it will go through another thirty (30) day application process in which the commissioners will determine whether to approve an extension, move forward with another application process or have a city administered program.

Mayor Fuller called for Council and Manager Comments.

She recognized Ms. Deborah Bradford and her team for their hard work in putting on such a successful back-to-school event at Woodside Village. She recently went to Washington D.C. with city staff members to meet with elected officials regarding McKinney and need for infrastructure support and grant funding as the region continues to grow and she acknowledged the city staff for their support of the community.

City Manager Grimes reminded everyone that MISD school starts back on Thursday, August 8 and he encouraged those traveling to be patient and slow down during their commute. He also reminded everyone that on Friday, August 9 the budget presentation will be held in the Council Chambers and information regarding the budget can be found on the website as well.

Mayor Fuller acknowledged Buzz Colby and his impact. He recognized Mayor Pro Tem Feltus in how well she represented the Council on her recent trip. He attended the MISD Convocation and encouraged everyone to watch the video of Harvey Oaxaca and Shawn Pratt. He acknowledged the Love Life Foundation Donuts with Superhero's event and thanked everyone for their donations of school supplies who helped put on a successful event. He acknowledged the staff at Medical City of McKinney. He thanked the McKinney Parks Foundation for their work on the trails in Craig Ranch. He thanked Davd Kelly for his work regarding the Leadership McKinney scholarship in honor of Buzz Colby.

Purpose of Vote

 - -Sets ceiling for FY25 Tax Rate
- · Required for proposing tax rate
- Proposed tax rate ceiling is at \$0.416922
- Current tax rate for FY24 is at \$0.427513
- City Manager's recommended tax rate in the budget will be less than the tax rate ceiling

MCKINNEY

No-New-Revenue and Voter-Approval Tax Rates

- The no-new-revenue tax rate is a calculated rate that would provide a taxing unit with the same amount of revenue it received in the year before on properties taxed in both years
- If property values rise, the no-new-revenue tax rate will go down and vice versa
- The voter-approval tax rate is 3.5% above the no-new-revenue tax rate
 - An election is required if the voter-approval tax rate is exceeded



AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, ORDERING AN ELECTION TO BE HELD IN SAID CITY ON NOVEMBER 5, 2024, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY OF MCKINNEY, TEXAS, CERTAIN PROPOSED AMENDMENTS TO THE EXISTING CITY CHARTER; DESIGNATING THE PLACES AT WHICH SAID ELECTION IS TO BE HELD; APPOINTING THE EARLY VOTING CLERK; MAKING PROVIDING FOR NOTICE AND PUBLICATION OF THE ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE

- WHEREAS, the City Council of the City of McKinney, Texas ("City") has, on its own motion, determined to submit to the qualified voters of said City for their adoption or rejection thereof certain proposed amendments to the existing Home Rule Charter of said City ("City Charter"), pursuant to the provisions of Section 9.004 of the Texas Local Government Code, and
- WHEREAS, the meeting at which this Ordinance is considered is open to the public as required by law, and public notice of the time, place and purpose of said meeting was given as required by Section 551.043 of the Texas' Government Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS:

- Section 1. That a special charter election is hereby ordered to be held on November 5, 2024, between the hours of 7:00 a.m. and 7:00 p.m. in accordance with the applicable provisions of the Texas Election Code, and the City Charter of McKinney, Texas as amended.
- Section 2. That an election be held for the purpose of submitting to the resident, qualified voters of the City of McKinney, Texas certain proposed amendments to the existing City Charter of the City of McKinney, Texas, as set forth in Section 3 of this Ordinance.

Section 3. Proposed Charter Amendments

That at the Election the following amendments to the City Charter shall be submitted to the resident, qualified voters of the City of McKinney, Texas:

PROPOSITION A

Shall Section 9 of the McKinney City Charter be amended to read as follows:

"Sec. 9. Council election. - There shall be held in the City of McKinney on the uniform election date in May 2025, and every four (4) years thereafter, or on such date or dates as may be prescribed by the laws of the State of Texas, a City election for a Mayor, a Council Member-at-large 1, a Council Member representing District 1, and a Council Member representing District 3.

There shall be held in the City of McKinney on the uniform election date in May 2027, and every four (4) years thereafter, or on such other date or dates as may be prescribed by the laws of the State of Texas, a City election for a Council Member-at-large 2, a Council Member representing District 2, and a Council Member representing District 4.

Each person duly elected to the position of Mayor or Council Member shall perform the duties and discharge the obligations conferred and imposed upon them, respectively, by the law, this Charter and by the City

Ordinances of McKinney and shall hold their office for a period of four (4) years and until their successors are elected and qualified. Beginning with the 2025 election, and every election thereafter, the Mayor shall be allowed to hold his/her seat for a limit of three (3) consecutive, full four-year terms, including three (3) terms consisting of a currently-held four-year term. Beginning with the 2025 election, and every election thereafter, each person duly elected to the position of Council Member shall be allowed to hold any at-large seat, including consecutive terms in separate district or at-large seats, for a limit of three (3) consecutive, full four-year terms, including three (3) terms consisting of a currently-held four-year term. Beginning with the 2025 election, and every election thereafter, each person duly elected to the position of Council Member shall be allowed to hold any district seat, including consecutive terms in separate district or at-large seats, for a limit of three (3) consecutive, full four-year terms, including three (3) terms consisting of a currently-held four-year term. After serving three (3) consecutive terms in an at-large or district seat(s), an at-large member shall not be eligible to serve in a district or at-large seat until the passage of one (1) year from the end of such three (3) consecutive terms; however, such member may serve as Mayor. After serving three (3) consecutive terms in an at-large or a district seat(s), a district member shall not be eliqible to serve in an at-large or district seat, until the passage of one (1) year from the end of such three (3) consecutive terms; however, such member may serve as Mayor?"

PROPOSITION B

Shall Section 16 of the McKinney City Charter be amended to read as follows:

*Sec. 16. - Council Compensation. Beginning October 1, 2025 for any newly-elected Council Member or a newly-elected Mayor, each member of the City Council, exclusive of the Mayor, shall receive the sum of seven hundred fifty dollars (\$750.00) per month as compensation for the performance of their official duties. The Mayor shall receive the sum of one thousand dollars (\$1,000.00) per month as compensation for the performance of his/her official duties. On October 1, 2027 and annually thereafter on the same date, the compensation shall be adjusted by an amount equal to the percentage change in the Consumer Price Index, Dallas-Fort Worth-Arlington for All Urban Consumers (CPI-U) over the prior, one-year period. In the event that the Mayor Pro Tem serves as Mayor for more than thirty (30) consecutive days, the Mayor's compensation shall be awarded to the Mayor Pro Tem. In addition, all actual reimbursable expenses, including eligible expenses allowed by State law, incurred by all members of the City Council in the performance of their official duties shall be paid by the City."?

PROPOSITION C

Shall the McKinney City Charter be amended throughout to correct nonsubstantive errors such as misspellings, punctuation, grammar, and sentence structure; conform notice and publication requirements to state law; harmonize conflicting sections; and revise references to repealed or obsolete provisions of state law?

PROPOSITION D

Shall the McKinney City Charter be amended to delete provisions, practices and policies which are no longer employed by the City of McKinney?

Section 4. The polling places are identified in Exhibit "A" attached hereto and incorporated herein by reference as a part hereof for all purposes. The election officers and maximum number of clerks for each polling place shall

be determined and appointed in accordance with the provisions of an election services contract to be executed with the Collin County Elections Administrator.

Section 5. That the method of voting to be used in the general election on Election Day, Tuesday, November 5, 2024, Early Voting in Person, Early Voting by Mail, and Provisional Voting, be the ExpressVote Universal Voting System, EVS 6.0.2.0 consisting of Electionware election management software, ExpressVote ballot marking device, ExpressTouch curbside voting device, DS200 precinct tabulator/scanner, DS450 high speed central scanner, and DS850 high speed central scanner, in accordance with the Texas Election Code., as amended, so as to permit the electors to vote "Yes" or "No" on each of the individual Propositions. Said ballots shall have such provisions, marking, and language as may be required by law, and a summary of the Propositions shall be set forth on said ballots in substantially the following form and language:
