Background

- Current solid waste license agreement was executed in 2008, amended in 2013 and 2021, and expires September 30, 2024
- Agreement allows for annual CPI-U adjustments on January 1
- CPI-U adjustment for calendar year 2023 is estimated at 6.5%
- Commercial rates increased 25% over a 3-year period per the agreement
- No increase to commercial rates in FY2024



Annual CPI-U Rate Adjustments

Current Basic Residential Rates

- Plano \$23.60

- McKinney \$17.92

- Richardson \$25.00

- Average \$21.12

- 2023 CPI-U Rate Adjustment

- 6.5% Increase (Estimated)

- Current Rate - \$17.92

- Proposed Rate - \$18.61

 Should rates be adjusted to reflect contractual CPI-U increase?

Current Solid Waste Rate Study

- License agreement with Frontier approved in August 2023
- Begins October 1, 2024, and includes new rate structure
- Burns & McDonnell Consulting performing cost of service analysis
- Develop residential and commercial rates over 5-year period
- Recycling as separate charge, disposal fees, revenues, etc.
- Rate study completed by March 2024, present to City Council for consideration
