

**ORDINANCE NO. 2026-03-\_\_\_\_**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2025-2026 BUDGET FOR REIMBURSEMENT OF MAINTENANCE FUNDS TO THE TRINITY FALLS MUD#1 AND MUD#2; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures / expenses in the Fiscal Year 2025-2026 Annual Budget and submitted same to the City Council for its approval and a true and correct copy is attached.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2025-2026 Annual Budget is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$562,655 from the General Fund balance for Reimbursement of Park Maintenance Funds to the Trinity Falls MUD #1 and MUD #2.
- Section 3. This Ordinance shall become effective from and after its adoption and is so ordained.
