Announcement Notice of Funding Availability PY 2024/FY 2025

Consolidated Grants Application Process:

Community Development Block Grant

Community Support Grant

Under the Community Grants Advisory Commission, the City of McKinney anticipates conducting public meetings in February and public hearings in May, and August 2024, to obtain input from all interested parties including, but not limited to public service agencies, homeless persons, housing providers, education providers, and residents to make recommendations to the City Council concern the allocation of funding of the following grants:

### **Community Development Block Grant (CDBG) PY 2024-2025**

(October 1, 2024 to September 30, 2025)

CDBG funds are provided to eligible organizations and must be used primarily to benefit low- and moderate-income persons residing within McKinney city limits, including homeless persons, abused children, youth, battered spouses, disabled persons, and elderly persons. Possible activity uses of the funds may include public facilities and infrastructure activities; affordable housing impacts and the provision of public services including but not limited to, counseling, legal assistance, housing, employment, crime prevention, childcare, health, job creation, safety, education, fair housing, energy conservation, welfare, or recreation. Up to 15% of the grant amount may be provided for public services.

### **Community Support Grant (CSG) PY 2024-2024**

(October 1, 2024 to September 30, 2025)

CSG funds are provided to non-profit agencies that benefit McKinney residents within city limits. Grant priorities for awarded activities are as follows:

- Basic Needs: including Food and clothing, Housing and Shelter, Non-financial Assistance
- Health and Medical Treatment: Including Mental Health
- Housing: Financial Assistance
- Transportation: The sole service being provided

On or around February 26, 2024, the application will be made available via the City of McKinney website at 1:00 PM, [www.mckinneytexas.org/grants](http://www.mckinneytexas.org/grants). Applications must be completed and submitted online through the city's Grant Portal by April 3, 2024, time-stamped no later than 11:59 PM CST (9:59 PM Pacific).

For interested organizations, two information meetings will be held.
