CITY COUNCIL SPECIAL MEETING

NOVEMBER 28, 2023

The City Council of the City of McKinney, Texas met in special session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, November 28, 2023 at 4:30 p.m.

Mayor George Fuller called the meeting to order at 4:31 p.m. having determined a quorum of the City Council consisting of himself and the following members were present:
