

RESOLUTION NO. 2026-08-____ (R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACT AMENDMENT WITH AEROCLOUD SYSTEMS INC. FOR THE MCKINNEY NATIONAL AIRPORT COMMERCIAL TERMINAL COMMON USE SYSTEM (AI2250); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF

WHEREAS, The City of McKinney has entered into a Framework Agreement with AeroCloud Systems Inc. for the McKinney National Airport Commercial Terminal Common Use System (AI2250); and

WHEREAS, City staff determined that additional Flight Information Display System (FIDS) monitors are needed in the baggage claim area and at Gates 5 and 6 to provide operational flexibility and redundancy during operations; and

WHEREAS, the proposed amendment to the original Commercial Addendum provides for nine (9) additional FIDS display units, together with associated cabling and software licenses; and

WHEREAS, the proposed amendment to the original Commercial Addendum increases the amount of the Framework Agreement by a total amount of \$74,667.27 over the remaining five-year term of the agreement, increasing the total contract value to an amount not to exceed \$500,853.45; and

WHEREAS, funding for Year 1 of the amended contract, in the amount of \$208,291.93, is available from Capital Improvement Program project AI2250, with the remaining contract costs to be included in the Airport's operating budget in the applicable future fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The foregoing recitals are hereby found to be true and correct legislative and factual findings of the City of McKinney, Texas, and are fully incorporated into the body of this Resolution.

Section 2. The City Manager is hereby authorized to execute the new Commercial Addendum to the existing Framework Agreement with AeroCloud Systems Inc. for the McKinney National Airport Commercial Terminal Common Use System (AI2250), in a total amendment amount of \$74,667.27, increasing the total contract value to an amount not to exceed \$500,853.45 over the five-year term of the agreement.

Section 3. This Resolution shall take effect immediately from and after the date of its passage and is so resolved.
