

ORDINANCE NO. 2025-06-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS TO DESIGNATE A 20-MINUUTE LOADING ZONE ON CHESTNUT STREET BETWEEN LOUISIANA AND CLOYD STREET AND DESIGNATE 20-MINUUTE LOADING ZONES WITHIN THE PUBLIC PARKING LOT ON THE NORTH SIDE OF CLOYD STREET BETWEEN JOHNSON STREET AND CHESTNUT STREET; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62–447 (10) of the Code of Ordinances to read as follows:

(10) One space on the west side of Chestnut Street beginning approximately 110 feet south of the intersection of Louisiana Street and Chestnut Street extending 25 feet southward along Chestnut Street.

Section 2. The City Council of the City of McKinney, Texas hereby amends Section 62–447 (11) of the Code of Ordinances to read as follows:

(11) Two spaces on the north side of the public parking lot along Cloyd Street between Johnson Street and Chestnut Street beginning 10 feet from Johnson Street extending 18 feet eastward.

Section 3. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 4. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
