- Incumbents receiving at least 4 points were prioritized over non-incumbents receiving more votes, for retaining a Regular seat and / or being promoted from Alternate to Regular
- Incumbents listed in red are members who have exceeded term limits
- Points for members who have resigned were not counted

These nominations are for informational purposes to assist the City Council with the Boards & Commissions Appointments Process.

Council action is required to confirm all appointments.
