CITY COUNCIL REGULAR MEETING

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, January 2, 2024, at 6:00 p.m.

The meeting was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at https://mckinneytx.new.swagit.com/views/130. A video recording of the meeting is available to members of the public through the City of McKinney meeting archive.

Mayor George C. Fuller called the meeting to order at 6:00 p.m. upon determining a quorum consisting of himself and the following City Council members were present: Mayor Pro Tem Charlie Philips, and Council members Justin Beller, Patrick Cloutier, Geré Feltus, Rick Franklin, and Michael Jones.

There were approximately thirty-five (35) members of the public present in the audience including McKinney Community Development Corporation (MCDC) Secretary David Riche.

Mayor Fuller called for the Invocation, given by Mayor Pro Tem Charlie Philips, and the recital of the Pledge of Allegiance.

Mayor Fuller called for the Regular Agenda and Public Hearing items:

The resolution authorizes the City Manager to negotiate an agreement with the preferred development team M2G Ventures LLC of Fort Worth, TX.

Director of Planning Jennifer Arnold provided an update on the annexation process, indicating that two public hearings are part of the requirements. While no action regarding the item was requested on this meeting date, the next meeting at which this item is presented will include a request for the Council to act on annexation and zoning for the subject property.

Council took no action on the item.

Mayor Fuller called for Citizen Comments on matters not on the agenda.

Dianca Bell, 703 Throckmorton PI, McKinney TX 75069, requested the Council to become involved with investigating the McKinney Housing Authority, expressing that she and other residents were illegally evicted.

Lisa Washington, 1250 Central Expressway Suite 210, McKinney TX 75070, thanked City Council members for supporting the non-profit organization Lead By

Example, and invited them to participate in the organization's upcoming bingo program for senior citizens.

Mayor Fuller called for Council and Manager Comments.

Council member Michael Jones announced that tickets are on sale for the Hugs Café fundraising gala to be held February 17 at the Allen Merriott at Watters Creek; wished everyone a happy new year; expressed excitement for the upcoming year of service as a member of the City Council and invited people who wished to contact him to do so by using the phone number he has provided to the public.

Council member Geré Feltus mentioned that Hugs Café was recently featured on the Kelly Clarkson television show representing the non-profit organization as well as the McKinney community in a positive way; recognized Jason Hernandez and the nonprofit community store La Tiendita for feeding children during the holidays.

Mayor Pro Tem Charlie Philips encouraged everyone to visit and support the La Tiendita store in east McKinney and not be deterred by roadway and new City Hall construction in the nearby area; and recognized cheerleader Katie McGill (University of Texas) and football player Brandon Frazier (Auburn University) who are both graduates of McKinney schools and have completed their collegiate careers.

Council member Rick Franklin expressed appreciation for the opportunity to participate in the annual Christmas parade, noting that participation and attendance appears to grow each year.

Council member Patrick Cloutier recognized the Giving Machine fundraising initiative organized by the Church of Jesus Christ of Latter-day Saints and acknowledged Dr. Tonya Stafford-Manning who founded the It's Going to be OK non-profit organization which brings awareness and healing to those affected by human trafficking and sexual exploitation. Council member Cloutier said the donations in McKinney led all other Giving Machine events in the state of Texas, thanked Matt Hamilton for hosting the Giving Machine event at his LOYO Outfitters location, and thanks Leadership McKinney participants Brian Medina and Lisa Washington for attending the City Council meeting.

Assistant City Manager Steve Tilton wished everyone a happy new year; announced the programs for homeowners and renters to recycle Christmas trees will
