

PETITION FOR INCLUSION OF PROPERTY INTO MCKINNEY TIRZ#1

The undersigned, being the owners of the tracts of property described in the attached Exhibit A (the "Property") and further identified by Collin County Central Appraisal District Property ID numbers set forth on Exhibit B (the "CAD Data Sheet"), do hereby petition to have the Property annexed and included within the boundaries of the McKinney TIRZ#1.

The Property is primarily vacant land with substandard and inadequate public infrastructure including, but not limited to, deteriorated streets and undersized/inadequate water and sewer services, thereby significantly impeding any meaningful development. Potential development of the Property is also hampered by the lack of adequate vehicular and pedestrian access to Elm Street, McDonald Street and Industrial Boulevard.

The inclusion of the Property into TIRZ#1 will allow development projects undertaken thereon to qualify for economic assistance through the tax increment reinvestment process, subject to the rules and procedures promulgated by the City of McKinney and the TIRZ#1 Board.



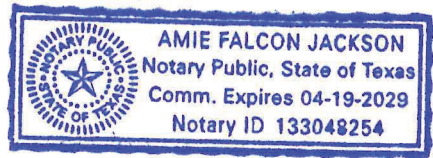
