

TAX INCREMENT REINVESTMENT ZONE NUMBER ONE BOARD

MAY 5, 2026

The Reinvestment Zone Number One of the City of McKinney, Texas met in regular session in the Council Chambers, 401 E. Virginia Street, McKinney, Texas, on Tuesday, May 5, 2026, at 5:00 p.m.

TIRZ1 Board Chair Rick Franklin called the meeting to order at 5:53 p.m. upon determining a quorum of the board consisting of himself and the following members were present: Patrick Cloutier, Michael Jones, Darrell Hale, Steve Lebo, Geré Feltus, Justin Beller, Bill Cox, and Ernest Lynch.

Board members unanimously approved the motion by Board member Patrick Cloutier, seconded by Board member Geré Feltus, to approve the Minutes and refer them to the City Council for Council approval.

Kyle Redel (Applicant) made comments in support of the request. The applicant's presentation is included in these minutes as *Appendix A: 26-0387 Applicant's Presentation*.

No other members of the public requested to speak.

The Board discussed a previously approved request by Union Bear that is similar to the request by The Parks Church and the necessity of policy to address similar requests in the future.

The Board did not approve the motion by Board member Darrell Hale, seconded by Board member Bill Cox, to fund two hundred thousand (\$200,000) dollars toward the request. The vote was 3 to 6, with Board members Steve Lebo, Michael Jones, Geré Feltus, Patrick Cloutier, Rick Franklin, and Justin Beller voted against the motion.

The Board approved by Board member Geré Feltus, seconded by Board member Michael Jones, to approve a resolution for the agreement and funding the entire requested amount, with a vote of 5 to 4. Board members Steve Lebo, Ernest Lych, Darrell Hale, and Patrick Cloutier voted against the motion.

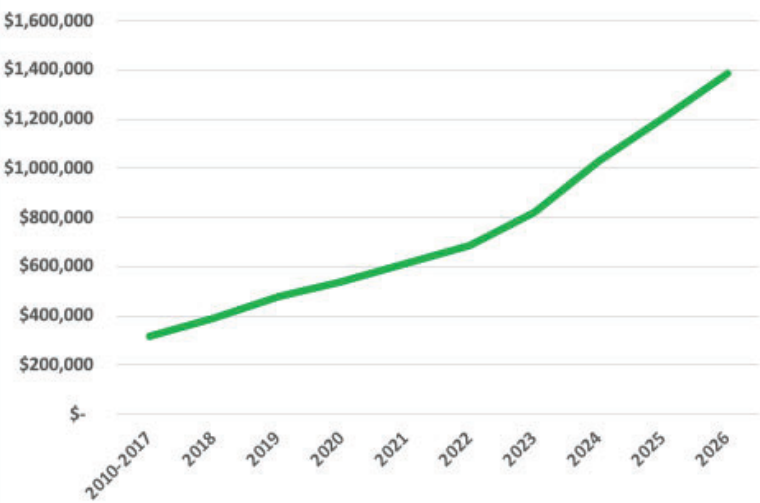
