Consultation and Citizen Participation:

We will engage citizens and stakeholders to assist in identifying housing and community development needs. Community, Faith-Based, Governmental and Business organizations, as well as residents, neighborhoods, and departments working together.

Needs Assessment:

McKinney will collect and analyze quantitative data including demographic information; any racial or ethnic disproportionality in households with severe housing problems; the housing and services needs of households with low- or moderate-incomes (LMI), people experiencing homelessness, and other special populations. We will compare our previous data against new assessments to determine future needs and planning for 2025-2029 programming.

Market Analysis:

Quantitative data to complete an analysis of the housing and economic market conditions and the condition of housing and facilities for LMI households, people experiencing homelessness, and other special populations.

Community in Service: Reducing Homelessness Assisting Unhoused Residents

Through grants and other activities, the City of McKinney serves to address homelessness and assist residents at-risk.

Services



- The city co-created the McKinney Homeless Coalition, a collective of city departments, faith-based and nonprofit agencies to address the plight of homelessness.
- Public Service and Homelessness response grants to nonprofit agencies, providing case management, shelter and supportive services.
- *Point-in-Time Count*, within Collin County of unsheltered persons, purposed to determine needs, and allows data collection to determine funding resources.
- McKinney SOAR – Street Outreach Ambassadors and Resources
