Consider/Discuss/Act on the Request by Robert Smith for Approval of aHistoric Marker for the Property Located at 215 North Morris Street

Ms. Cassie Bumgarner, Historic Preservation Planner for the City of McKinney, explained the proposed request and discussed the history of the property. She stated

that Staff recommends approval of the request and offered to answer questions. There were none. Mr. Robert Smith, 215 N. Morris Street, McKinney, TX, discusses work completed on the property. He thought that the windows were all original to the house. On a motion by Vice-Chairman McWilliams, seconded by Board Member Hanes, the Board unanimously voted to approve the request per Staff's recommendation, with a vote of 7-0-0.

Ms. Cassie Bumgarner, Historic Preservation Planner for the City of McKinney, explained the proposed request and briefly discussed the work completed on the property. She stated that Staff recommends approval of the request and offered to answer questions. There were none. The applicant was not present at the meeting. She discussed the following current programs: social media outreach, various tours given, new online process for certification of appropriateness applications, and new order of the Historic Preservation ordinances (203.C.4) within the Code of Ordinances. Ms. Nasta discussed the following opportunities for Historic Preservation: new Historic Resource Survey for 2023, possibly expanding the Historic District, creating a Preservation Plan, creating a Design Guidelines or Standards and the draft 2002 Design Guidelines to use as a draft, and Certified Local Government program and funding opportunities. The Board Members were interested in pursuing the Design Guidelines, expanding the districts, Preservation
