

**ORDINANCE NO. 2026-06-\_\_\_**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING A CERTAIN BUDGET AMENDMENT PERTAINING TO THE FISCAL YEAR 2025-2026 BUDGET AND THE 2026-2030 CAPITAL IMPROVEMENTS PROGRAM FOR OUTDOOR WARNING SIREN (OWS) UPGRADES AND REHABILITATION (FP2638); AND PROVIDING FOR AN EFFECTIVE DATE HEREOF**

**WHEREAS**, as required by the City Charter, the City Manager has prepared an amendment to certain appropriations and expenditures/expenses in the Fiscal Year 2025-2026 Annual Budget and the Fiscal Year 2026-2030 Capital Improvements Program and submitted same to the City Council for its approval and a true and correct copy is attached; and

**WHEREAS**, the City's annual Outdoor Warning Siren preventative maintenance inspections identified multiple sirens requiring upgrades or rehabilitation due to age-related deterioration, structural degradation, and electrical component failures, and

**WHEREAS**, the City Council finds that funding these improvements is necessary to maintain the reliability and operational readiness of the Outdoor Warning Siren system for the protection of life and property during emergency warning events.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. Pursuant to the City Charter requirements of the City of McKinney, Texas, a Budget Amendment pertaining to the Fiscal Year 2025–2026 Annual Budget and the 2026-2030 Capital Improvements Program is hereby authorized and approved.
- Section 2. The budget shall be amended by appropriating \$200,000 from the Public Safety Improvement Fund balance to the Capital Improvement Program for Outdoor Warning Siren Upgrades and Rehabilitation (FP2638).
- Section 3. This Ordinance shall become effective from and after its adoption and is so ordained.
