

**RESOLUTION NO. 2026-01-\_\_\_\_ (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS,  
ADOPTING A SUSTAINABILITY ROADMAP TO GUIDE EFFICIENT  
RESOURCE MANAGEMENT, OPERATIONAL EXCELLENCE, AND QUALITY  
OF LIFE IMPROVEMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of McKinney, Texas, is committed to balancing growth with the efficient use of resources in order to maintain infrastructure, protect public health, and preserve a high quality of life for residents and businesses; and

**WHEREAS**, the City Council has identified sustainability as a priority within its Strategic Goals, including advancing Operational Excellence and supporting the development of sustainable quality of life improvements; and

**WHEREAS**, responsible management of solid waste, water resources, stormwater systems, and factors affecting local air quality promotes fiscal responsibility by reducing long-term operational costs, extending the useful life of City assets, and minimizing the need for reactive maintenance; and

**WHEREAS**, the City Council previously directed the Public Works Department to develop a Sustainability Roadmap to translate Council priorities into measurable objectives and actionable strategies aligned with community values and local needs; and

**WHEREAS**, the Sustainability Roadmap focuses on four key areas critical to City operations and community well-being:

- Materials Management (solid waste and recycling);
- Water Conservation;
- Stormwater Management; and
- Air Quality; and

**WHEREAS**, the Sustainability Roadmap emphasizes operational efficiency, data-driven decision-making, and voluntary behavior-change strategies supported through education, incentives, partnerships, and grant opportunities; and

**WHEREAS**, implementation of the Sustainability Roadmap is intended to prioritize partnerships, external funding opportunities, and operational efficiencies in order to limit reliance on taxpayer dollars;

**NOW, THEREFORE, BE IT RESOLVED THAT:**

Section 1. The City Council of the City of McKinney, Texas, hereby adopts the Sustainability Roadmap as a guiding framework for City operations,

planning efforts, and programs related to efficient resource management, environmental stewardship, and the enhancement of community quality of life.

- Section 2. The Sustainability Roadmap shall guide the identification and prioritization of measurable goals, performance targets, and action items, all of which shall remain subject to future City Council approval as required by applicable law, City policy, or budgetary authority.
- Section 3. This resolution shall take effect immediately from and after the date of passage and is so resolved.
