

CITY COUNCIL REGULAR MEETING

JANUARY 16, 2024

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, January 16, 2024, at 6:00 p.m.

The meeting was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at <https://mckinneytx.new.swagit.com/views/130>. A video recording of the meeting is available to members of the public through the City of McKinney meeting archive.

Mayor George C. Fuller called the meeting to order at 6:18 p.m. upon determining a quorum consisting of himself and the following City Council members were present: Council members Justin Beller, Patrick Cloutier, Geré Feltus, Rick Franklin, and Michael Jones. Mayor Pro Tem Charlie Philips was absent due to illness.

Mayor Fuller called for Council and Manager Comments.

Council member Feltus announced upcoming activities related to Black History Month: Celebration of Historic Black Churches in McKinney will be 10:15 a.m. on Sunday, February 4 at The First Baptist Church of McKinney; February 17 College Megafest event (in partnership with St. Mark Baptist Church) more than 1,300 students are already registered for the event; the Gather venue will host a Gospel Brunch (February 18), the CUTX Living Color Awards event (February 21), and the Amethyst Market featuring black-owned businesses (February 22); Chief Executive Officer of the Dallas Mavericks Cynt Marshall will be the guest speaker of the CEO Breakfast Series on February 22; and the 1990s themed Hip Hop House Party will be March 1 at The Sanctuary Music and Events venue.

Council member Beller recognized the staff of McKinney Independent School District, Visit McKinney, and others who helped organize the NCAA Division II Football Championship game held at McKinney ISD Stadium in December; expressed celebration for his alma mater Harding University winning the championship; and expressed appreciation for the opportunity to showcase the city of McKinney through the event.

City Manager Paul Grimes announced the McKinney Public Library System and McKinney Parks & Recreation department released their respective activity guides for

the upcoming Spring season. The guides are available at various public facilities and online on the city's webpage.

The Council members individually thanked the individuals who made public comments and acknowledged how the events in Gaza impact many people within the McKinney community. Mayor stated that he would pen a letter to legislators on the subject of the war. Mayor Fuller also acknowledged his son Raine who served as a Golden Knight in the United States Army.

Council unanimously approved the motion by Council member Geré Feltus, seconded by Council member Rick Franklin, to adjourn the meeting at 7:22 p.m.
