## ORDINANCE NO. 2025-08-\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS TO MODIFY THE EFFECTIVE REDUCED SPEED SCHOOL ZONE TIMES FOR SCHOOLS WITHIN THE PROSPER INDEPENDENT SCHOOL DISTRICT; AMENDING THE CODE OF ORDINANCES, CITY OF McKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Section 62–225.1 of the Code of Ordinances to read as follows:

Sec 62-225.1. Same - Speed.

The speed limit for the vehicles traveling the streets within the Rock Hill High School zone during the hours of 7:25 a.m. to 8:55 a.m. and 3:35 p.m. to 5:00 p.m., school days, shall be 20 miles per hour maximum.

Section 2. The City Council of the City of McKinney, Texas hereby amends Section 62–313.1 of the Code of Ordinances to read as follows:

Sec 62-313.1. Same - Speed.

The speed limit for the vehicles traveling the streets within the Hughes Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:55 p.m. to 3:55 p.m., school days, shall be 20 miles per hour maximum.

Section 3. The City Council of the City of McKinney, Texas hereby amends Section 62–314.1 of the Code of Ordinances to read as follows:

Sec 62-314.1. Same – Speed.

The speed limit for the vehicles traveling the streets within the Reeves Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:55 p.m. to 3:55 p.m., school days, shall be 20 miles per hour maximum.

Section 4. The City Council of the City of McKinney, Texas hereby amends Section 62–319.1 of the Code of Ordinances to read as follows:

Sec 62-319.1. Same - Speed.

The speed limit for the vehicles traveling the streets within the Furr Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:55 p.m. to 3:55 p.m., school days, shall be 20 miles per hour maximum.

Section 5. The City Council of the City of McKinney, Texas hereby amends Section 62–330 of the Code of Ordinances to read as follows:

**Sec 62-330. Same – Speed.** 

The speed limit for the vehicles traveling the streets within the Baker Elementary School zone during the hours of 7:05 a.m. to 8:05 a.m. and 2:55 p.m. to 3:55 p.m., school days, shall be 20 miles per hour maximum.

Section 6. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 7. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
