EVENT DESCRIPTION

The 7th Annual *McKinney Wine & Music Festival* will take place on Saturday, October 14th from 12pm-5pm at Towne Lake Park!

We had another successful year in 2022 bringing out nearly 5,000 attendees to Towne Lake Park and increasing our paid attendance by over 10%. Nearly 70% of those attendees came from outside Mckinney. In 2023 we hope to increase attendance to over 6,000

The festivities include local musicians, wine tastings, a VIP tent experience, grape stomping, culinary demonstrations and lots of great shopping. The event partners with over 100 local small business owners giving them an opportunity to showcase their business!

Every year the Mckinney Wine & Music Festival gives back to local non-profits and in 2022 we were able to give back over \$4,500 to The Warriors Keep, Love Life Foundation and the Frisco Women's League.

OBJECTIVES AND GOALS

Our continued long term objective with the Mckinney Wine & Music Festival is to promote tourism and attract visitors to McKinney. Putting an emphasis on local Mckinney business, wineries, musicians and shopping. We'd like to grow the festival and its attendance year over year!

Inflation, and the effects of the pandemic, are still an issue for the events industry and the grant would play a HUGE role on our marketing & advertising efforts to bring visitors to McKinney.

This event has a fantastic presence and reputation of being a fun festival in McKinney, TX! It highlights McKinney as a unique and fun destination. The festival offers local McKinney businesses opportunities to sell their products and promote their business!



The event continues to put an emphasis on cultural arts in McKinney and continues to expand the music portion of the event, highlighting McKinney as a Music Friendly Community.

Social media remains the most important form of advertising the events and the money spent on PR is also very helpful because it secures a variety of television spots and articles with DFW publications.

ADDITIONAL INFORMATION

The event receives over 10 million impressions that bringing tourism and hotel stays to McKinney! We have learned best practices to get the word out and promote the event effectively with the awarded grant funds.

The cost of tickets will vary with wine passes starting at \$30.

Our event expenses are expected to be \$100k-\$110k and we are requesting \$7,000 to help us afford the advertising necessary to continue to grow the event. Our gross revenue is planned to be at \$170k this year.

We anticipate seeing our expenses continue to increase and fluctuate in 2023. Making the grant more needed than ever!

Hi Andrew,

I have received and reviewed your grant application and I didn't see anything missing, however, I did see that your event 7th Annual Mckinney Wine & Music Festival takes place on October 14, 2023.

I know you are aware because we discussed it in the last grant cycle you were awarded funds, but I want to avoid any surprises further down the road and therefore I want to highlight, that outlined in our grand guidelines on the bottom of page 4 it states:

"All approved Advertising & Promotional grants must be completed as provided in the performance agreement. <u>All funds must be distributed by Sept. 30</u> of the fiscal year in which the grant was awarded unless prior consent is secured from Visit McKinney by Aug. 30 of that same fiscal year."

Since our Fiscal Year runs October 1 through September 30th, we need all re-imbursement requests for the grant buttoned up the very lasted beginning of August/mid-August to allow time to write reimbursement checks before 9-30-2022. Re-imbursement can take up to 30 days.

Please let me know in an email that you are aware of this requirement and whether there are any changes to the application (taking this timeline into consideration) or if we are proceeding with the application as submitted because the advertising and promotion dollars will be spent by the end of our fiscal year, even though the event itself is shortly thereafter.

Whatever you send me I will add to the documents and you can address it in the presentation to the board.

Details about meeting date/time and presentation rules will be sent out later today.
