#1. Advisory Committee (Amendment)

Local Government Code, Sec. 395.058(b)

- Now prohibits the Planning and Zoning Commission from serving as, or being, the Capital Improvements Advisory Committee ("CIAC").
- Requires that not less than 50 percent of the membership of the CIAC must be representatives of the real estate, development, or building industries who are not employees or officials of a political subdivision or governmental entity -- with no exceptions.
- Persons that serve on the City Council or other City boards and commissions or boards and commissions of another governmental entity or political subdivision are considered "officials" and their number on the CIAC is limited to less than 50 percent of the members on the CIAC.
- Because utility impact fees are assessed and collected in the extraterritorial jurisdiction ("ETJ") the membership of the CIAC must include a representative from the ETJ.
- Chapter 130 of the McKinney Code will have to be amended to establish the CIAC in compliance with the changes established by SB 1883.


