

CITY COUNCIL WORK SESSION

MARCH 19, 2024

The City Council of the City of McKinney, Texas met in work session in the Council Chambers, 222 N. Tennessee Street, on Tuesday, March 19, 2024 at 4:00 p.m.

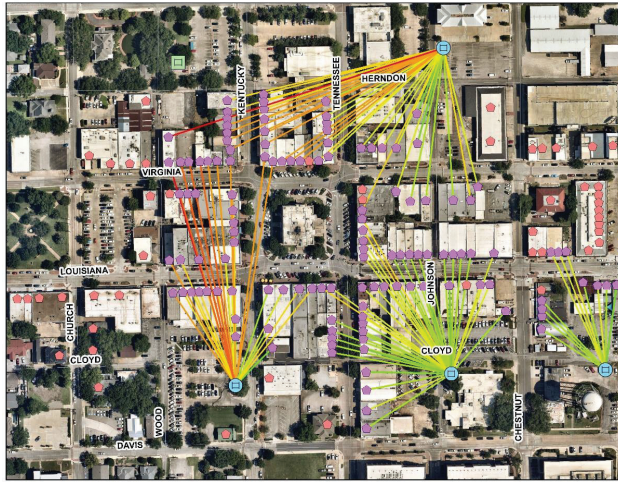

Solid Waste Management Strategy Timeline and Process



CBD Trash Services

- Current Operations
 - Four centralized dumpster locations
 - 70 – 95 gallon carts
 - Trash is picked up six days per week
 - Businesses pay Waste Connections Directly (38% participation rate, 69/180+)



CBD Trash Finances

- Currently 69 accounts in the CBD pay approximately \$62,000 per year
- Current Solid Waste Rate Study estimates that the cost of service for CBD is \$850,000 per year

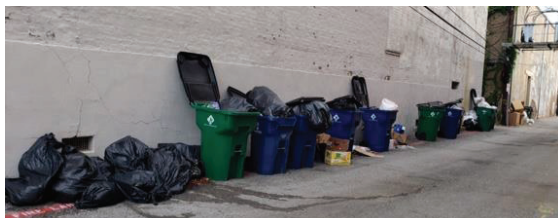

Isolated Cost of Service Rate Model

Each customer class is assigned respective costs



Shared Cost of Service of Rate Model

CBD costs are shared across commercial businesses as follows:

- Year 1 – All CBD Business pay for service at current rates
- Year 2 – 25% of CBD costs paid by CBD businesses
- Year 3,4,5 - 50% of CBD costs assigned to CBD businesses



Averaged Shared Cost of Service of Rate Model

Same as B, except rates are averaged over 5 years

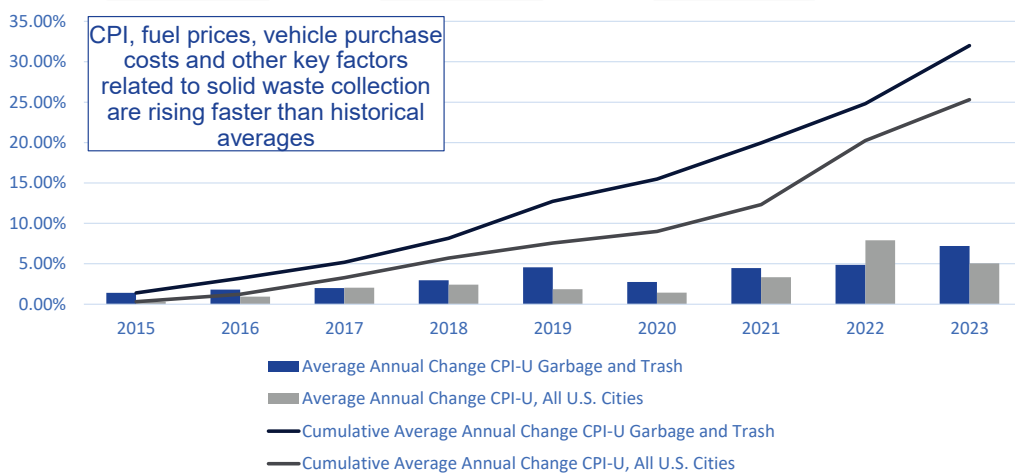
Allocation of Costs to Cost Centers

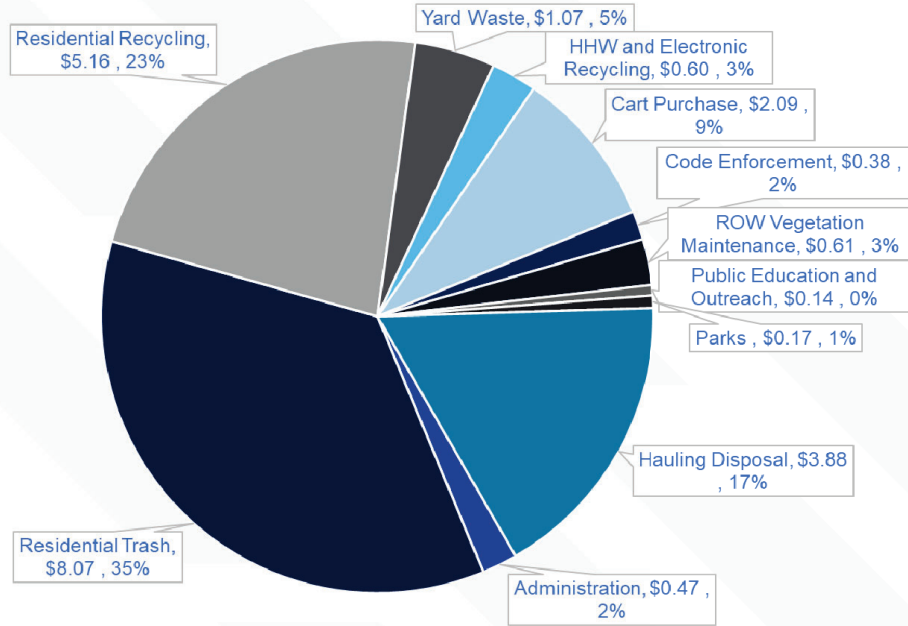


Five-year historical average increase to CPI-U Garbage and Trash is 4.77%

Forecasting Considerations and Assumptions

- Solid waste rates were historically high enough to sustain the fund through cost adjustments from the prior contractor without pass throughs to residents
 - The City's ability to absorb these costs has decreased in recent years
 - Additional solid waste services provided by the City have historically not been accounted for by residential and commercial rates
 - The City recently procured a competitive and cost-effective collection contract from Frontier Waste Solutions
- Assumptions:
 - Initial cart roll-out program includes grant funding equal to \$15 per recycling cart
 - Carts are managed with a 7-year useful life with replacement occurring in FY 2031
 - Low commodity price recycling market

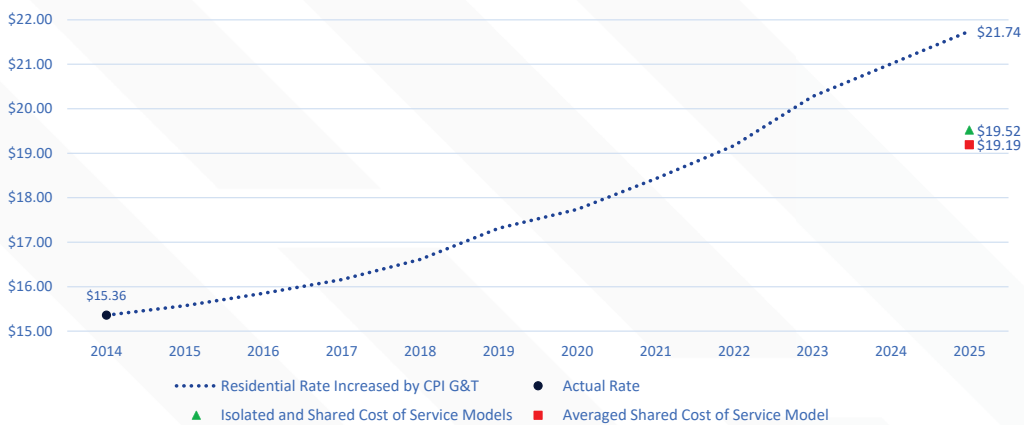

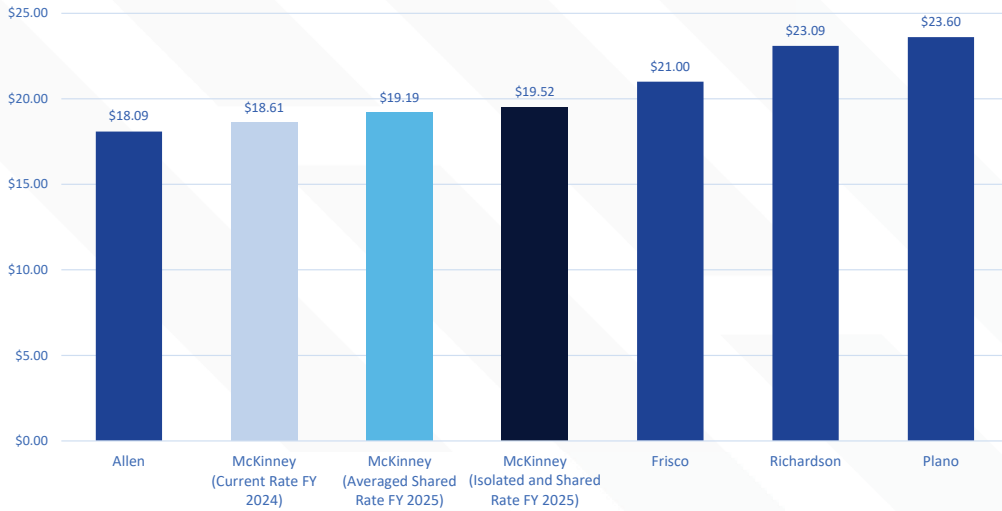

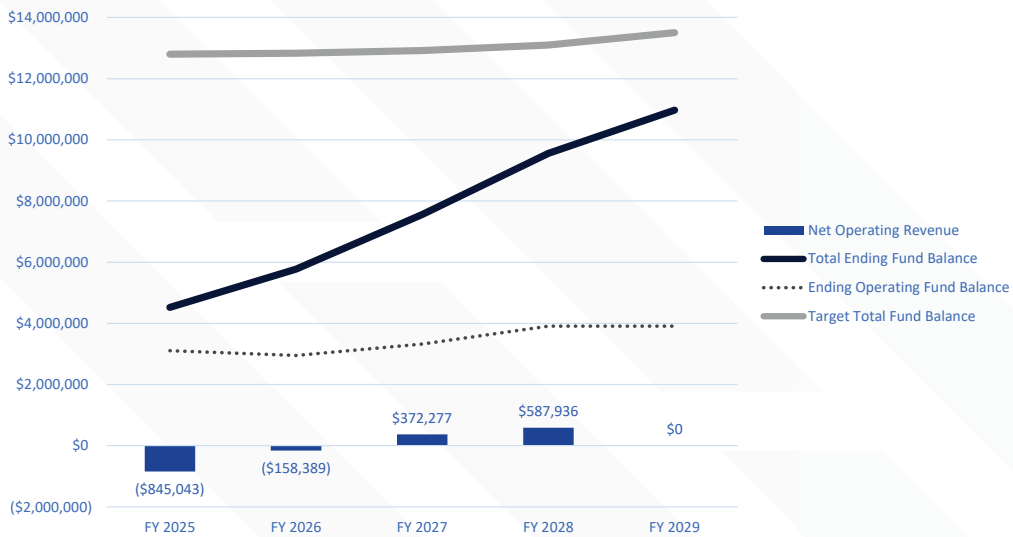

Target Fund Balance:

- 90-day operating reserve
- Cart replacement cost requirements based on a 7-year cart useful life

Cart Replacement:

- Money set aside for cart replacement counted as an expense
- Savings for cart replacement added back into in the Ending Fund Balance

- Frontier starts collection services on October 1, 2024

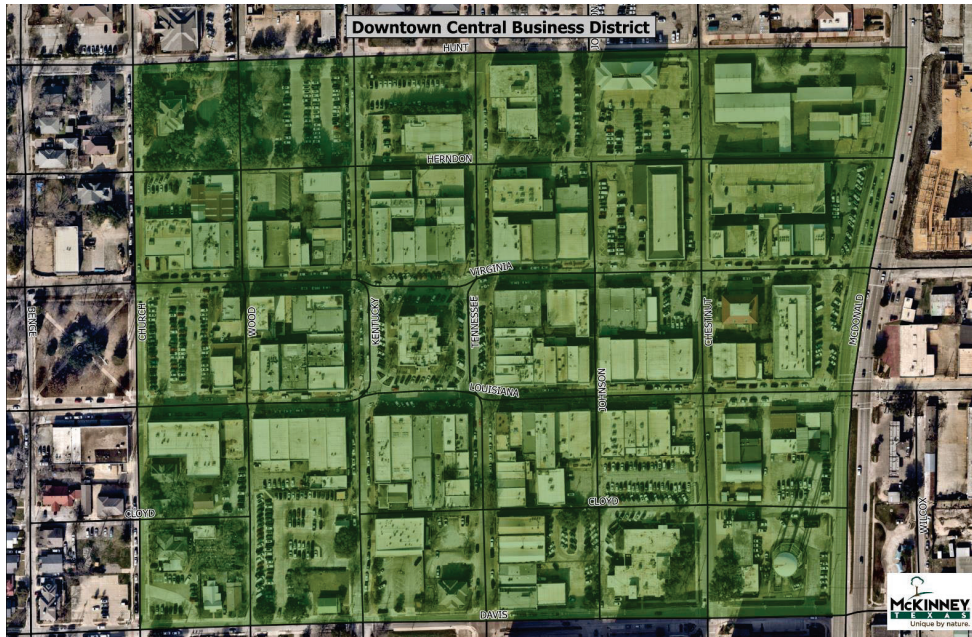

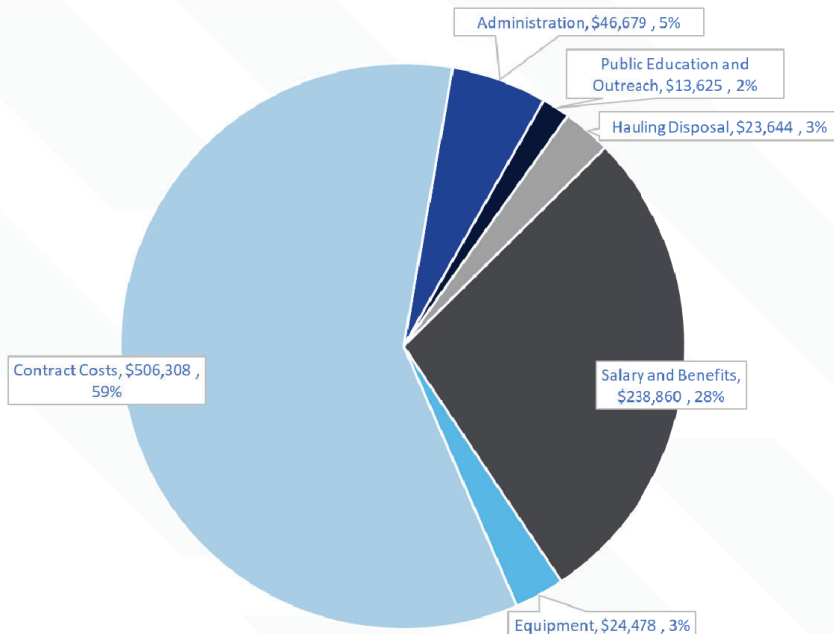
CBD Rate Structure Option

MCKINNEY AIRPORT ADVISORY BOARD TIMELINE

- **OCTOBER 6, 1977**
 - The first Airport Advisory Board meeting was held
- **OCTOBER 16, 2007**
 - City Council adopted a resolution approving the Articles of Incorporation and Bylaws for the McKinney Airport Development Corporation (MADC)
- **APRIL 1, 2008**
 - City Council approved a resolution approving an administrative services agreement between the City of McKinney and the MADC
- **SEPTEMBER 3, 2013**
 - City Council approved an Asset Purchase Agreement for real property and business assets at the airport (Purchase of FBO)
- **SEPTEMBER 17, 2013**
 - City Council approved a resolution adopting amended bylaws for the McKinney Airport Development Corporation
- **OCTOBER 2, 2015**
 - Articles of Dissolution filed with State of Texas formally disbanding the MADC

MCKINNEY AIRPORT ADVISORY BOARD BACKGROUND

- **THERE WERE BETWEEN 5 AND 7 AIRPORT BOARD MEMBERS, APPOINTED BY CITY COUNCIL**
 - Members were residents of McKinney or owned or were employed by a McKinney business
 - Up to 2 members could be residents of Collin County, or own or be employed by a Collin County business
 - Officers included a President, Vice President, Secretary and Treasurer
- **SERVED AS AN ADVISORY BOARD TO CITY COUNCIL**
- **MET MONTHLY, OCCASIONALLY CALLING SPECIAL MEETINGS (BI-MONTHLY AFTER NOVEMBER 2014)**
- **IN ADDITION TO THE AIRPORT BOARD AND ADMINISTRATIVE STAFF, MEETINGS WERE PERIODICALLY ATTENDED BY:**
 - Mayor and City Council members
 - CMO/City staff
 - MEDC/MCDC staff
 - ATCT manager

MCKINNEY AIRPORT DEVELOPMENT CORPORATION BACKGROUND

- BETWEEN 2007 AND 2013 THE CITY COUNCIL DELEGATED ADDITIONAL AUTHORITY TO THE MADC
 - Airport Management Agreement: April 2008
 - Manage the airport (operations, development, marketing, promotion of services)
 - Hire Airport Manager
 - Oversee capital projects (planning, contracting, negotiating, engaging consultants)
 - Approval of capital expenditures identified in approved budget not subject to further approval
- IN 2013 THE COUNCIL DOWNGRADED THE ROLE OF THE MADC TO AN ADVISORY CAPACITY
 - Second Amended Bylaws of MADC: October 2013
 - Advising instead of acting on behalf of the City
 - No longer independently manage and operate the airport
 - Removed authorization to hire an Executive Director (transferred to City Manager)
 - City's Finance Department assumed responsibility for custody and security of all Airport funds and for compiling financial reports.

- REVIEWED PROPOSED FEE SCHEDULES FOR FBO AND AIRPORT LAND LEASE RATES

- ADMINISTRATIVE WORKLOAD (AIRPORT AND CITY STAFF)
- RESPONSIVENESS (TIMELY ACTION ITEMS TO CITY COUNCIL)
- POTENTIAL FOR CONFLICTS OF INTEREST – BOARD MEMBERS WHO ARE DRAWN FROM AIRPORT BUSINESSES, USERS, TENANTS INFLUENCING RATES AND CHARGES POLICIES, LEASE TERMS, ETC.
 - Airport as owner of FBO – aeronautical services provider

WHAT ARE OTHER NATIONAL AIRPORTS DOING?

- TKI STAFF REACHED OUT TO OTHER TEXAS NATIONAL GA AIRPORTS TO SURVEY ON THEIR GOVERNANCE STRUCTURE
 - Arlington: no advisory board
 - Addison: no advisory board (disbanded in the late 1990's)
 - Dallas Executive Airport: no advisory board
 - Ellington: no advisory board
 - Georgetown: no advisory board (disbanded)
 - Sugar Land: no advisory board

 - Denton: advisory board
 - Ft. Worth Alliance & Meacham: advisory board (same board advises both airports)
 - Conroe/North Houston: advisory board
 - New Braunfels: advisory board
 - San Marcos: advisory board
