A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A SUPPLEMENTAL AGREEMENT NUMBER 5 WITH JOHNSON, MIRMIRAN AND THOMPSON, INC. FOR ADDITIONAL ENGINEERING DESIGN SERVICES FOR THE TENNESSEE STREET, LAMAR STREET, AND HUNT STREET INFRASTRUCTURE IMPROVEMENTS PROJECT FOR AN INCREASE IN THE NOT TO EXCEED FEE FROM \$2,400,000 TO A TOTAL AGGREGATE CONTRACT AMOUNT, INCLUSIVE OF ANY ADDITIONAL SUPPLEMENTAL AGREEMENTS, NOT TO EXCEED \$2,650,000

WHEREAS, the City Council of the City of McKinney, Texas, recognizes the need for the additional design services for the Tennessee Street, Lamar Street, and Hunt Street Infrastructure Improvements Project (CO2409); and

WHEREAS, the City has received a proposal from Johnson, Mirmiran and Thompson, Inc. to provide additional design services for the Tennessee Street, Lamar Street, and Hunt Street Infrastructure Improvements Project (CO2409).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Manager is hereby authorized to execute a supplemental agreement with Johnson, Mirmiran and Thompson, Inc. to provide additional professional engineering services for the design of the Tennessee Street, Lamar Street, and Hunt Street Infrastructure Improvements Project (CO2409) for an increase in the not to exceed fee from \$2,400,000 to a total aggregate contract amount, inclusive of any additional supplemental agreements, not to exceed \$2,650,000.

Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
