MINUTES OF THE BOARD OF COMMISSIONERS MEETING HOUSING AUTHORITY OF THE CITY OF MCKINNEY

The meeting of the Board of Commissioners of the Housing Authority of the City of McKinney, Texas, was held at 1200 N. Tennessee St. at 5:15p.m. on May 25, 2010.

Chairman Arthur Simmons called the meeting to order at 5:18 p.m. and established a quorum.

Chairman Simmons called for comments from the public. There were no comments.

The first order of business was to review and adopt the minutes of the meeting held April 27, 2010. Commissioner Dennis Williams motioned to approve the minutes as presented. Commissioner Elinor Williams seconded the motion. A vote was taken with the following results.

Chairman Simmons then called for the next item on the agenda which was to consider/discuss/act on a Special Presentation to Community Organizations and Volunteers – 3E McKinney, Seed Sowers/DV8 and Cornel Wasserman. Executive Director Beth Bentley advised the Board that the agency would be introducing some of the groups that have partnered with the agency to serve our clients. Ms. Bentley highlighted a recent project that had more than two hundred volunteers to assist with apartment make ready's and the playground. There after she gave a brief overview of the projects that have been on going with 3E and DV8. Ms. Bentley also thanked staff for their participation. A video presentation about DV8 was viewed. After the video Elaine Danielson stood and gave an overview of Seed Sowers and their mission. Ms. Danielson then asked Kim Simpson to speak about the DV8 program. Ms. Simpson has designed the curriculum for working with the children that participate in DV8. Ms. Simpson provided a brief summary of the activities, volunteers and goals. Then Ms. Stephanie Tyson stood to speak about the group's community outreach and its efforts to break down barriers. Commissioner Williams asked general questions regarding the establishment of the group and advised of his delight to hear of their collaboration with McKinney ISD. Ms. Bentley and the MHA staff presented the awards and the group took pictures with the Board. Chairman Simmons asked Elaine Simpson to provide the board information regarding Monarch House prison ministry. Ms. Simpson gave a brief overview of the vision she hoped to bring into fruition. The audience applauded the efforts and the Chairman asked for other comments. Nicky Leeks made a brief comment to thank everyone for all the work being done. The Chairman directed the participants to partake in the refreshments provided.

Chairman Simmons called for the next item, consider/discuss/act on the Public Housing Admissions and Occupancy Policy. The Executive Director advised the board that the agency still had additional items to include in the final policy. Therefore her request was to table the item along with the next item until the next meeting. Both item six and seven were tabled.
