**WHEREAS**, the City Council authorizes the City Manager to make application for Community Development Block Grant Funds (CDBG) and HOME Investment Partnership funds; and

**WHEREAS**, the City of McKinney engaged public participation through public hearings, focus groups, consultations, public meetings and comments, to prepare for awareness, participation, and acceptance of the Consolidated Plan; and

**WHEREAS**, activities and programs under the Consolidated Plan submission includes the first program year, October 1, 2025 – September 30, 2026; and

**WHEREAS**, the U.S. Department of Housing and Urban Development will review and give final approval of the plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The draft 2025-2029 Consolidated Plan is hereby approval for submittal to HUD upon completion of all requirements.

Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.





**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, APPROVING THE FY 2026 (PY 2025) ANNUAL ACTION PLAN FOR CDBG AND HOME FEDERAL FUNDS AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the City Council of the City of McKinney, Texas, authorizes the City Manager to make applications for, accept and administer Community Development Block Grant (CDBG) Funds and HOME Investment Partnership Program funds; and

**WHEREAS**, the U.S. Department of Housing and Urban Development will review and confirm acceptance of providing the CDBG and HOME funds for access under the Annual Action Plan program year, to begin October 1, 2025, and

**WHEREAS**, the city conducted and continues to engage the public through required public hearings, public comments, and focus groups and meetings, for the engagement of meaningful participation and input; and

**WHEREAS**, CDBG activities include public services, housing, community development and grant administration, and HOME activities include Tenant Based Rental Assistance; and

**WHEREAS**, proposed CDBG and HOME funding, activities, and programs are listed under program year one of the 2025-2029 Consolidated Plan submission for the City of McKinney; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

Section 1. The City Council of the City of McKinney, Texas hereby adopts the 2025-2026 Annual Action Plan with funding allocations as follows:




