OCTOBER 5, 2010

The City Council of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on October 5, 2010 at 6:00 p.m.

Council unanimously approved the motion by Council member Ussery, seconded by Council member Kever, to approve the Resolution appointing eight (8) members to the Tax Increment Reinvestment Zone Number One Board of Directors which would include the Mayor and six Council members and the Chairman of the Planning and Zoning Commission. Council unanimously approved the motion by Council member Kever, seconded by Council member Ussery, to appoint Council members District 2, District 4, and At Large (2) to one year terms ending September 30, 2011, and to appoint Mayor, Council members District 1, District 3, At Large (1), and Planning and Zoning Commission Chairman to two year terms ending September 30, 2012. 10-091Z Mayor Loughmiller called for а Public Hearing for Consideration/Discussion/Action on the Request by Robert H. Roeder, on Behalf of Seeds For The Future, L.P., Baylor Health Care System, and Franklin Family Partnership for Approval of a Request to Rezone Approximately 27.90 Acres, from "PD" - Planned Development District (Mixed Uses) to "O" - Office District and "BG" - General Business District; and to Rezone Approximately 156.51 Acres, from "AG" - Agricultural District to "RS 72" - Single Family Residence District, "C" - Planned Center District, and "BG" - General Business District, Generally Located on the Southeast Corner of FM 1461 (Lake Forest Drive) and Geren Trail, and Accompanying Ordinance. Planning Director Jennifer Cox stated that the applicant is requesting to rezone approximately 27.90 acres of land, located on the south side of Geren Trail and approximately 2,000 feet east of F.M. 1461 (Lake Forest Drive), from "PD" - Planned Development District to "O" - Office District and "BG" - General Business District; and to rezone approximately 156.52 acres, from "AG" -Agricultural District to "C" - Planned Center District, "BG" - General Business District, and "RS 72" - Single Family Residence District. No immediate development plans have been proposed for the zoning tracts. Staff is recommending approval with the special ordinance provisions. Applicant, Mr. Bob Roeder, 1700 Redbud, Suite 300, McKinney was available to answer questions from Council. Mayor Loughmiller called for public comment. The following individual spoke in favor: Mr. Bill Gross, 4879 Geren Trail, McKinney. Council unanimously approved the motion by Council member Ussery, seconded by Council member Ricchi, to approved the ordinance rezoning approximately 27.90 acres, from "PD" -Planned Development District (Mixed Uses) to "O" - Office District and "BG" - General Business District; and to rezone approximately 156.51 acres, from "AG" - Agricultural District to "RS 72" - Single Family Residence District, "C" - Planned Center District, and "BG" - General Business District, generally located on the southeast corner of FM 1461 (Lake Forest Drive) and Geren Trail, with the following special ordinance provisions: The use and development of 97.24 acres of the subject property, as shown on the proposed Zoning Exhibit (Exhibit C), shall develop in accordance with the "RS 72" - Single Family Residence District regulations of the Zoning Ordinance; the use and development of 24.05 acres of the subject property, as shown on the proposed Zoning Exhibit (Exhibit C), shall develop in accordance with the "O" - Office District regulations of the Zoning Ordinance; the use and development of 50.00 acres of the subject property, as shown on the proposed Zoning Exhibit (Exhibit C), shall develop in accordance with the "C" - Planned Center District regulations of the Zoning Ordinance; and the use and development of 3.70 acres of the subject property, as shown on the proposed Zoning Exhibit (Exhibit C), shall develop in accordance with the

Council member Kever returned to the dais.

10-060Z Mayor Loughmiller called for Public Hearing for а Consideration/Discussion/Action on the Request by Nash Group Real Estate, on Behalf of Reyburn Anderson, Wanda Perry Anderson, and Kimberly Anderson Mayer, for Approval of a Request to Rezone Approximately 37.67 Acres, from "AG" - Agricultural District and "REC" -Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District, Generally to Modify the Development Standards, Located on the East Side of Custer Road and Approximately 500 Feet South of Synergy Drive, and Accompanying Ordinance. Planning Director Jennifer Cox stated that the applicant is requesting to rezone approximately 37.67 acres of land, located on the east side of Custer Road and approximately 500 feet south of Synergy Drive from "AG" - Agricultural District and "REC" - Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District, generally to allow "BN" Neighborhood Business uses and "O-1" Neighborhood Office uses. The applicant has not yet indicted any future plans for development of the subject property. Staff is recommending approval. Applicant, Mr. Jack Harvard, 5559 Lago Vista, Frisco, stated that he is representing the Anderson Family that owns the property. There are no plans at this time to use it for anything else other than agricultural. Mayor Loughmiller called for public comment and there were none. Council unanimously approved the motion by Council member Brooks, seconded by Council member Kever, to approve the Ordinance rezoning approximately 37.67 acres, from "AG" - Agricultural District and "REC" - Regional Employment Center Overlay District to "PD" - Planned Development District and "REC" - Regional Employment Center Overlay District, generally to modify the development standards, located on the east side of Custer Road and approximately 500 feet south of Synergy with the following special ordinance provisions: Use and Drive, development of the subject property (37.67 acres), more fully depicted on proposed Zoning Exhibit B, shall conform to the following regulations: Tract 1 (17.82 acres) shall be developed in accordance with Section 146-84 "BN" - Neighborhood Business District of the City of McKinney Zoning Ordinance and "REC" - Regional Employment Center Overlay District, Restaurant or cafeteria (including drive-through except as follows: window) shall be allowed by right without a specific use permit (SUP), Tract 2 (19.85 acres) shall be developed in accordance with Section 146-87 "O-1" - Neighborhood Office District the City of McKinney Zoning Ordinance and "REC" - Regional Employment Center Overlay District, except as follows: the incidental retail sale of food, beverages, and other convenience items or services is permitted to the occupants, employees, and guests, as long as these items are not advertised nor offered for sale to the general public, an open space buffer shall be provided along the eastern property line of the subject property. The width of the buffer must

be a minimum of 50 feet and must extend at least 15 feet west of the Erosion Hazard Setback Easement, whichever is greater; a development plan, per the requirements of the "REC" - Regional Employment Center Overlay District's third (III) section (General Development Plan Requirements), shall be required prior to the approval of any site plan or plat for the subject property, subject to the review and approval by the Planning and Zoning Commission provided that the plan also meets the following special requirements: mutual access shall be provided in the northwest corner of the subject property to the adjacent property to the north, which is more fully depicted in the clouded area on the proposed zoning exhibit, access to the subject property from Custer Road shall be provided at existing median openings, more fully depicted on the proposed zoning exhibit. Additional access points may be allowed in accordance with the requirements of the City of McKinney's Street Design Manual, and a Hike and Bike Trail shall be provided on the subject property, and its alignment and location shall be finalized with the development plan in accordance with the Parks, Recreation and Open Space Master Plan then in effect. Mayor Loughmiller called for Council and Manager Comments

Mayor Pro-Tem Huff thanked Cathy Lennox for the work she does on Blue Star and Gold Star Flag program. Mr. Huff expressed his deepest sympathies to the Bury family for their loss. Mr. Huff stated that he was in Austin twice last week. One visit was for "Cities of Service" program. The program covers cities that come up with projects they want to see done. The Volunteer McKinney Center is taking the lead here and it will be a vehicle to tie volunteer groups together and get great things done for our City. Mr. Huff stated that his other trip to Austin was for a TxDOT Commissioners meeting, where he was reappointed for 3 years to serve on the Aviation Advisory Committee.

Council member Ricchi attended the McKinney Community Development Corporation meeting where the Samaritan Inn was given a \$40,000 grant and the Parks, Recreation and Open Space Department was granted \$99,000 for equipment. CASA held their golf event and raised \$50,000. Mr. Ricchi stated that the Fire Department has a program that installs 200 smoke alarms for residence in need. Mr. Ricchi announced that next year's Smiles Concert will raise money to build a home for a war veteran.

Council member Day did not have any comments.

Council member Kever stated that the Dallas Regional Mobility Collation serves as a subset of Regional Transportation Council. Last week we began a discussion to put projects on the table to prioritize. McKinney is hoping to get funding for the Highway 5 corridor, FM 546, and the US 380 interchange.

Mayor Loughmiller expressed his sympathies to the Bury family. "Recognitions like this cause us to pause and think of how lucky we are. The Mayor thanked the Fire and Police department for the work they do for the city. Reminded everyone to keep their eyes on the calendars with lots of events coming: Dickens of a Christmas. Support your local businesses. Mayor Loughmiller expressed his appreciation for the
