### Consider/Discuss/Act – Minutes of the October 14, 2009 Board Meeting

Mr. Rattan made a motion to approve the October 14, 2009 minutes. Vice-Chair Sharla Bush seconded. The board voted; the minutes were approved unanimously.

### <u>Chairman/Vice-Chairman Report – Board Retreat Recap/Discussion</u>

Chairman Galyean gave a recap on the Board Retreat last month and opened the discussion to the board. Chairman Galyean asked the board to please review the Board Retreat materials in their board packets. The board discussed each of the goals for McKinney Main Street.

# <u>Chairman/Vice-Chairman Report – Downtown McKinney Bike Race</u>

Chairman Galyean reported to the board on the Downtown McKinney Bike Race. Chairman Galyean announced that since the retreat he, Ty Lake, Mayor Loughmiller, Councilman Day, MCDC Chairman Ray Eckenrode and McKinney Velo have met and have started putting together the Downtown McKinney Bike Race. The closed course crit (race) will be held Friday, June 11 in the evening. The event will tie into the Collin Classic which starts on Saturday and will be coming through Downtown McKinney for the very first time. McKinney Main Street will be responsible for the promotional and fundraising portion of this race. Mrs. Lake added that in an effort to get store participation is the option of decorating bicycles in each window downtown to tie into the event and then auction the artistic creations. The board discussed.

#### Chairman/Vice-Chairman Report – New Business Updates/Store Closings

Chairman Galyean turned the New Business Update and Store Closings over to Mrs. Lake. Mrs. Lake reported that Sippitydoodle will be closing their doors after seven months in business, Square Burger has been reported to open in December, Poppy's Garden Café has closed and Café Malaga is moving to their location, Sugar Plums has moved from North Kentucky to East Louisiana, and the Fillmore Pub from downtown Plano will be opening in Goodhues' place along with a new home and garden consignment store will be opening in three weeks on East Virginia.

### **Directors Report – Monthly Recap**

Mrs. Lake presented her Monthly Report. The board reviewed and discussed.

#### **Directors Report – Oktoberfest Recap**

Mrs. Lake gave a brief recap on McKinney Oktoberfest 2009. Mrs. Lake stated that there is a full budget recap in each board packet for the board's review. Mr. Dell'Antonia and Mrs. Funderburgh both communicated their feedback and recommended areas of improvement for next year's event based on what they experienced while working at Oktoberfest. The board discussed.

# <u>Directors Report - Scare on the Square Recap</u>

Mrs. Lake gave a recap on Scare on the Square. Mrs. Lake stated that this year's Scare on the Square was the busiest to date; attracting approximately 4,000 people to the event. The dinosaur from the Heard Natural Museum was a huge success, a big thank you to Day 6 Creative for securing that for us and coming up with the idea. Mrs. Lake mentioned to the board that we will need to look at the timing and date for next years Scare as it falls on a Sunday. The board discussed.

#### **Directors Report – Dickens Specifics**

Mrs. Lake updated the board on the 29<sup>th</sup> Annual Dickens of a Christmas...Home for the Holidays.

Mrs. Lake passed out a Dickens Specifics report highlighting all the activities surrounding Dickens of a Christmas. The board discussed.

#### **Directors Report – Decorating Downtown Update**

Mrs. Lake gave a decorating Downtown update. As of right now we have 75 Image Campaign participants committed to the campaign and we will be able to request the \$10,000 from McKinney Alliance this week. The Board discussed.

#### **Review and Discuss Financials**

Mrs. Lake reported the financials year to date, in Treasurer John Dugan's absence. Mrs. Lake directed everyone to review the financials that were provided in the board packet. Mr. Dell'Antonia requested that in the future he would like to see an A/R report in the Board packet. The Board discussed and reviewed the statements with no further questions.

### Consider/Discuss/Act - On 2010 Main Street Events

Vice-Chair Bush asked each board member to review the 2010 Main Street events that were discussed at the Board Retreat located in your board packet. Vice-Chair Bush asked for a motion on the 2010 Main Street Events. Ms. Brewer made a motion that the 2010 Main Street Events include; Krewe of Barkus, ArtWalk...Downtown McKinney Is Hopping!, Bike Race, McKinney Oktoberfest, Scare on the Square and Dickens of a Christmas, as well as supporting Second Saturdays and removing the Red, White & BOOM! Car Show as a Main Street event. Vice-Chair Bush seconded the motion. The board voted; the minutes were approved unanimously.

Consider/Discuss/Act — On an Ordinance going before Council to Modify Locations of Loading

Zones in the Downtown area, Modifying Parking Designations Near the Municipal Courts Building

and Designating Three-Hour Parking Spaces along the North Side of Cloyd Street Between

Johnson Street and Chestnut Street.

Vice-Chair Bush introduced City of McKinney Engineer Robyn Root. Mrs. Root explained that this ordinance will be going in front of City Council and is more of a house keeping item, many of these stated changes have already occurred, but just for the records to keep up with reality the ordinance is being updated. Mrs. Root walk the board through the different loading zone changes as well as the modified parking designations and the new Three-hour parking designations. Mrs. Lake made a recommendation to remove one of two loading zones in front of Mama Emilia's and communicated that this amendment and been discussed and reviewed with Mr. Birch. The Board reviewed the ordinance presented to them and noted the amendment. Mr. Dell'Antonia made a motion to approve the new ordinance. Mr. Rattan seconded. The board voted; the minutes were approved unanimously.

Mrs. Cox turned the update on the Town Center Study over to City of McKinney Planner Jennifer Arnold. Mrs. Arnold reviewed Phase 2 of the Town Center Study; going over the Parking Analysis that just took place and what the next focus will be. The Phase 2 will go before City Council next week.
