

RESOLUTION NO. 2026-08-____ (R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE AN ADVANCE FUNDING AGREEMENT (AFA) FOR SURFACE TRANSPORTATION BLOCK GRANT (STBG) OFF-SYSTEM FUNDS WITH THE TEXAS DEPARTMENT OF TRANSPORTATION (TxDOT) FOR THE CONSTRUCTION OF LAUD HOWELL PARKWAY LANES 3 & 4 FROM LAKE FOREST DRIVE TO WEST OF TRINITY FALLS PARKWAY,

WHEREAS, the City Council of the City of McKinney, Texas, recognizes the need for the Advanced Funding Agreement with TxDOT to fund the construction of the Laud Howell Parkway FM 1461/Lake Forest Drive Project. Funding source utilized is the Federal Highway Administration CFDA No. 20.205 Highway Planning and Construction. Costs will be allocated based on 80% Federal funding and 20% Local Government funding until the Federal funding reaches the maximum obligated amount. The Local Government will then be responsible for 100% of cost overruns.

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

- Section 1. The City Manager is hereby authorized to execute an Advance Funding Agreement for Surface Transportation Block Grant (STBG) Off-System Funds with TxDOT for the construction of Laud Howell Parkway Lanes 3 & 4 from Lake Forest Drive to West of Trinity Falls Parkway (CIP Project ST2310).
- Section 2. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
- Section 3. This project has been approved by the Regional Transportation Council (RTC) for Surface Transportation Block Grant (STBG) funding and is included in the 2027-2030 Transportation Improvement Program (TIP)
