McKinney Community Development Corporation Update

- **Promotional and Community Event Grants**

- Applications for the final cycle of Promotional grants will be accepted May 1-29, 2026.
- Maximum award is \$15,000 and is restricted to advertising, marketing and promotional activities. Total funds available for the final cycle total \$125,470.

- **Project Grants**

- Presidium Group, LLC withdrew the application submitted during the first grant cycle, for infrastructure improvement at the Cotton Mill in an amount of \$13,634,638.
- Applications for the second cycle of Project grants were accepted through March 31.
- Public hearings on eligible projects will be scheduled for the April 23 board meeting.
- Attached is a summary of project grant requests received:

- **Retail Development Infrastructure Grants**

- Applications for the final cycle of Retail Development Infrastructure grants will be accepted through July 1-31, 2026.
- Eligible projects are restricted to exterior infrastructure – sewer, water, utilities, site work.

- **McKinney Front Porch**

- Inaugural Affordable Housing Summit took place on Monday, April 13th at the MISD Community Event Center.
- Keynote speaker was Dr. Cullum Clark, Director of Economic Growth at the George W. Bush Institute and author of a recent report, "Build Homes, Expand Opportunity: Lessons from America's Fastest Growing Cities."
- Ashlea Quinonez, Southwest Regional Administrator for the U.S. Department of Housing and Urban Development provided closing remarks.
- More than 300 were in attendance and included developers, nonprofit representatives, real estate professionals, city staff and Council members for informative presentations and discussion focused on addressing the affordable housing issue.
- Panel topics included innovations in approach to providing affordable housing product; employer and developer approaches and partnerships in place to provide affordable housing to employees; and making projects a reality – a discussion with developers and funders.
- McKinney Front Porch is a collaborative initiative, originally convened by MCDC that includes community stakeholders including City Council, City Manager's office, Planning, Housing and Community Development, McKinney Chamber of Commerce, MEDC, McKinney Housing Authority, Habitat for Humanity of Collin County, One Heart McKinney, financial institutions and other local leaders.

- **MCDC 30th Anniversary**

- April of 2026 will mark the 30th anniversary of MCDC.
- Celebration and recognition of this milestone will include a monthly presentation, at the MCDC board meeting, by one of our valued partners on the impact of projects supported over the years.

MCDC celebrates 30 years of investing in McKinney's quality of life

MCKINNEY, Texas (April 9, 2026) – The McKinney Community Development Corporation (MCDC) is celebrating 30 years of supporting projects that enhance the quality of life for residents across the community. Since its creation in April 1996, MCDC has invested over \$330 million, using revenue from a half-cent sales tax to support parks, recreation, cultural amenities, housing initiatives, community services and developments that make McKinney a vibrant place to live.

“These investments help shape the places and experiences that residents enjoy every day,” said MCDC Board Chairman George Fuller. “Unlike many communities in Texas that use Type B sales tax funding primarily for economic development, McKinney has taken a unique approach. The city splits a one-cent sales tax between the MCDC and McKinney Economic Development Corporation, allowing one organization to focus on corporate business and job growth while the other invests in amenities, events and retail opportunities that impact the daily lives of our residents.”

Over the years, MCDC has helped support a wide range of projects that enhance the community, including major parks and recreation facilities such as the Apex Centre, Bonnie Wenk Park and Old Settlers Recreation Center. The organization has also invested in community gathering spaces and events in Historic Downtown McKinney, including the restoration of the McKinney Performing Arts Center and popular annual events such as Historic McKinney Farmers Market, Oktoberfest, Home for the Holidays and Arts in Bloom. Additional investments have supported affordable housing partnerships with local organizations, cultural destinations like Chestnut Square, community nonprofits including Hugs Café, and destination developments such as the TUPPS Brewery project and District 121.

“These investments have helped strengthen McKinney's identity as a community known for its parks, historic downtown, cultural attractions and strong community partnerships,” said MCDC President Cindy Schneible. “As McKinney continues to grow, these projects help ensure we preserve the character and quality of life that residents value.”

As we celebrate 30 years of MCDC impact, we encourage residents to shop and dine in McKinney. Remember that local spending has a direct impact on our community.

Throughout April, MCDC will highlight several key areas of impact including parks and recreation, affordable housing and community partnerships, and destination developments that contribute to McKinney's vibrant economy and culture.
