

HISTORIC PRESERVATION ADVISORY BOARD

MARCH 6, 2025

The Historic Preservation Advisory Board of the City of McKinney, Texas met in regular session in the Council Chambers at 401 E. Virginia Street on Thursday, March 6, 2025 at 5:30 p.m.
