RECOMMENDED BOARD ACTION: Consider and recommend the adoption of the 2023 National Electrical Code, with proposed amendments.

ZONING: N/A

EXISTING CONDITIONS: The City of McKinney currently has adopted the 2020 National Electrical Code with corresponding amendments, but the State of Texas adopted the 2023 Edition September 1, 2023.

ITEM SUMMARY: NFPA, who publishes the National Electrical Code (NEC), updates their code on a three-year cycle. The Texas Department of Licensing and Regulation, which administers electrical licensing laws, establishes the mandatory edition of the NEC to be enforced throughout Texas, as empowered by the Texas Local Government Code. The 2023 National Electrical Code became the mandatory minimum standard for enforcement of electrical standards State-wide on September 1, 2023. Per State law, the Building Inspections Department has been enforcing the 2023 NEC for all permits initiated on or after that date. Although the 2023 NEC is already mandatory and enforceable under State law, the Code must be adopted into City Ordinance in order for the proposed Amendments to be in effect. This ordinance would be in effect immediately. The City of McKinney has historically adopted the Code amendments recommended by the North Central Texas Council of Governments. These updated amendments are being incorporated into the proposed ordinance, as well as continuing a few local amendments, with the adoption of this Code. The City of McKinney Building Inspections Department has endeavored to educate the public of upcoming changes through a mass email and documents posted on the City's website.
