Chairman Cox called the meeting to order at 6:12 p.m. after determining a quorum was present.

Chairman Cox called for public comments on non-public hearing agenda items.

Chairman Cox called for consideration of the Regular Agenda Items and Public Hearings.

23-0069Z Conduct a Public Hearing to Consider/Discuss/Act on a Request to Rezone the Subject Property from "PD" - Planned Development District and "C" - Planned Center District to "PD" - Planned Development District to Allow for Multi-Family Residential Uses and to Modify the Development Standards, Located on the Southeast Corner of Wilmeth Road and Community Avenue (REQUEST TO BE TABLED)

Kaitlin Sheffield, Senior Planner for the City of McKinney, stated that Staff recommends that the public hearing be continued and the request be tabled to the November 14, 2023 Planning and Zoning Commission meeting to allow additional time for Staff and the applicant to work on the proposed development regulations. Chairman Cox opened the public hearing and called for comments. There being none, on a motion by Commission Member Hagstrom, seconded by Commission Member Woodard, the Commission unanimously voted to continue the public hearing and table the request to the November 14, 2023 Planning and Zoning commission meeting per Staff's recommendation, with a vote of 7-0-0.

23-0091SP Conduct a Public Hearing to Consider/Discuss/Act on Design Exceptions to a Site Plan for Commercial Entertainment, Outdoor (McKinney Flour Mill), Located at 601 East Louisiana Street

Jake Bennett, Planner II for the City of McKinney, explained the proposed design exceptions to the site plan and Staff's concerns. He stated that Staff recommends denial of the request. James Bresnahan, 2805 Piersall, McKinney, TX, explained the proposed request. Chairman Cox opened the public hearing and called for comments. There being none, on a motion by Commission Member Hagstrom, seconded by Commission Member Wattley, the Commission unanimously voted to close the public hearing, with a vote of 7-0-0. Jake Bennett and James Bresnahan answered the Commission's questions regarding the proposed screening device on the subject property. Jennifer Arnold, Director of Planning for the City of McKinney, discussed Staff's concerns. James Bresnahan stated that he was willing to make some changes to the proposed screening device along Louisiana Street. Caitlyn Strickland suggested tabling the request so Staff and the applicant could work together on a new plan. James Bresnahan was comfortable with tabling the request.
