Parks & Recreation Director Amy Kinkade provided updates on staff accomplishments at TRAPS North Region Conference which included golf tournament 1st place finish, Maintenance Excellence Award, the Horizon Award and a Marketing award. Further

updates included the internal EPIC CON conference, Veterans Day Ceremony, upcoming Ribbon Cutting event for Recreation Center at Towne Lake and the Light Walk at Towne Lake Park on 12/3/25 and the addition of the phone of the Wind installation at Gray Branch Park. Parks Development updates included 21 active projects. Recreation Center at Towne Lake is open to the public, The Light Walk at Towne Lake Park, Greens Park and McKinney Soccer Complex Phase 2 are near completion. Ashwoods Park playground installation will start this week. Inspiration Park playground replacement will start in January. The contract for Gabe Nesbitt softball fourplex is routing for signatures. The Bob Tomes Dog Park bid documents are under review. Staff expects this project to go out to bid in the next month or two as well as, Gardy Littlejohn Sports Complex. Old Settlers Park renovations are in the design phase. The Regional Sports Complex is in review with Council to determine the guiding principals with RFQ scheduled for January. Erwin Park bid is in review; APEX elevator design is close to completion. Al Ruschhaupt Sports Complex construction projected to start quarter 2, 2026.
