Jake Bennett, Planner II for the City of McKinney, stated that Staff recommends that the public hearing be closed, and the item tabled indefinitely. He explained that the consideration of Design Exceptions by the Planning and Zoning Commission was no longer necessary, and the site plan was able to be approved at a Staff level. Chairman Cox opened the public hearing and called for comments. There being none, on a motion by Vice-Chairman Lebo, seconded by Commission Member Buettner, the Commission unanimously voted to close the public hearing and approved tabling the request indefinitely per Staff's recommendation, with a vote of 5-0-0.
